Directions to Friendship Park

From US-22 West - Take Hopedale Rt. 151 exit. Head South West on West Main St./Mill St. Take a slight left onto Ohio 151 for 7.5 miles. Turn left onto Bloomingdale County Rd. 23/Smithfield Rd. and continue for 0.4 mile. Take a sharp right turn onto Friendship Park Rd. and continue for 0.4 mile to the end of the street where it turns left up the hill.

From US-22 East - Follow US-22 to Steubenville, OH crossing the Veterans Memorial Bridge (over the Ohio River) stay to the right on the bridge and follow signs to State Rt. 7 South. 


