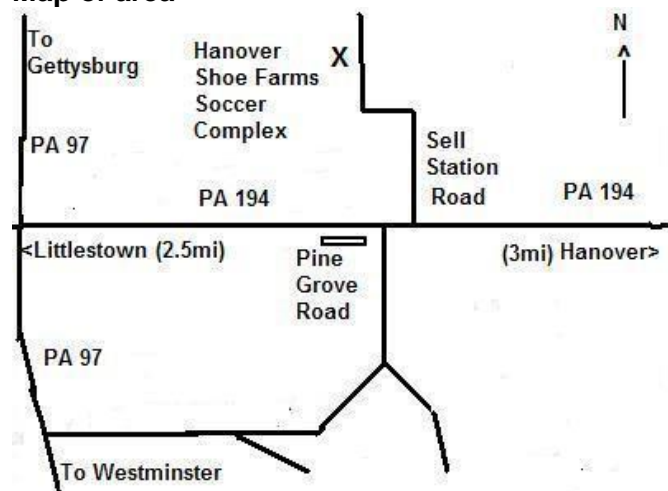
Direction to Hanover Shoe Farms, Sells Station Road Site:

EIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLES STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

Lure Coursing Instinct STAKE: Open to all Non-Sighthound breeds. All entries shall be individually registered with the AKC (including ILP & PAL), the UKC, the FCI, an ASFA recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. This stake will be limited to a total of 10 entries.

Small is for dogs shorter than 18 inches at the withers and / or brachycephalic ("flat-faced") dogs. **Large** is for dogs over 18 inches at the withers.

Small will run 50% of the course as laid out in this premium up to a maximum of 400 yards. All other sizes will run the full course length.

Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. The club reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial, included with the course plan. The course will be reversed for finals. runoffs and Best of Breed.

Notice for first time entered hounds: As of January 1, 2003, any hound which first time is entered in a trial, must have a copy of the hound's registration papers to send in with the entry. This is true if the hound is entering Open, Veteran, Singles of Limited Stake for the first time.

Hounds with breed disqualifications are not eligible to enter except in Single Stake.

Hounds will run twice, in trios if possible or braces (except in Single Stake), unless excused, dismissed or disqualified

Certifications will be offered on Saturday and Sunday after completion of the trial if weather, daylight, equipment, and judges permit. The cost is \$10.00 per hound.

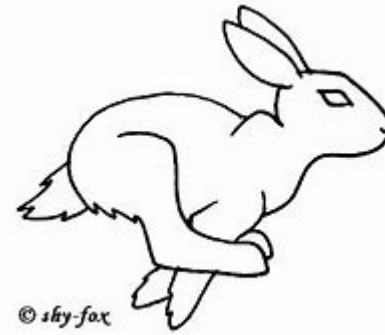
Practice will be offered on Saturday after certifications, weather or time permitting Cost is \$5.00 per run.

There will be a \$5.00 fine for any loose hound not participating in the course.

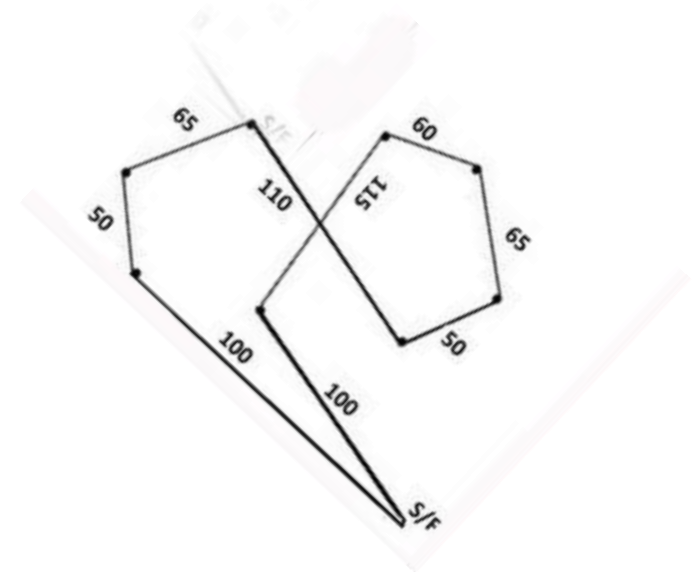
Lunch will be available after judges and workers have been fed. Price is \$5.00 per person which includes a drink. Bring a side dish or dessert and eat free.
