

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds, Sloughis, Whippets and Provisional breeds may be entered in the regular stakes.

- LCI: Depending on the number of entries, roll call and start times may be staggered for LCI dogs.
- Owners will swipe their female dog(s) and show the inspection committee the tissue.

Running the dogs:

• Competitors will be a minimum of 2 metres apart at the start.

Once you have finished Running your dog:

- There will be hand sanitizer available in designated areas.
- Virtual ribbons/certificates will be emailed.
