Ribbons

Rosettes will be offered for all placements, 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), High Scoring Single (navy/gold), & Best of Breed (purple/gold). **Prizes** will be awarded by RRRRCoM and friends of RRRRCoM for all 1st placements and Best of Breed.

Make checks payable to "RRRRCoM". Do NOT send entries "signature required". Late, incomplete, or unpaid entries will not be accepted. Entries will NOT be acknowledged by mail. Entries may be acknowledged by e-mail if a legible e-mail address is provided on the entry form. There will be a \$25 fee for any returned check.

Eligible Breeds & Registry

Only purebred Rhodesian Ridgebacks may be entered in the regular stakes.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.

Regular Stakes Offered

OPEN STAKE: Any eligible Rhodesian Ridgeback, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion Rhodesian Ridgeback of record.

VETERAN STAKE: Any eligible Rhodesian Ridgeback whose age is at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Not offered.

SINGLES STAKE: Any eligible Rhodesian Ridgeback including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

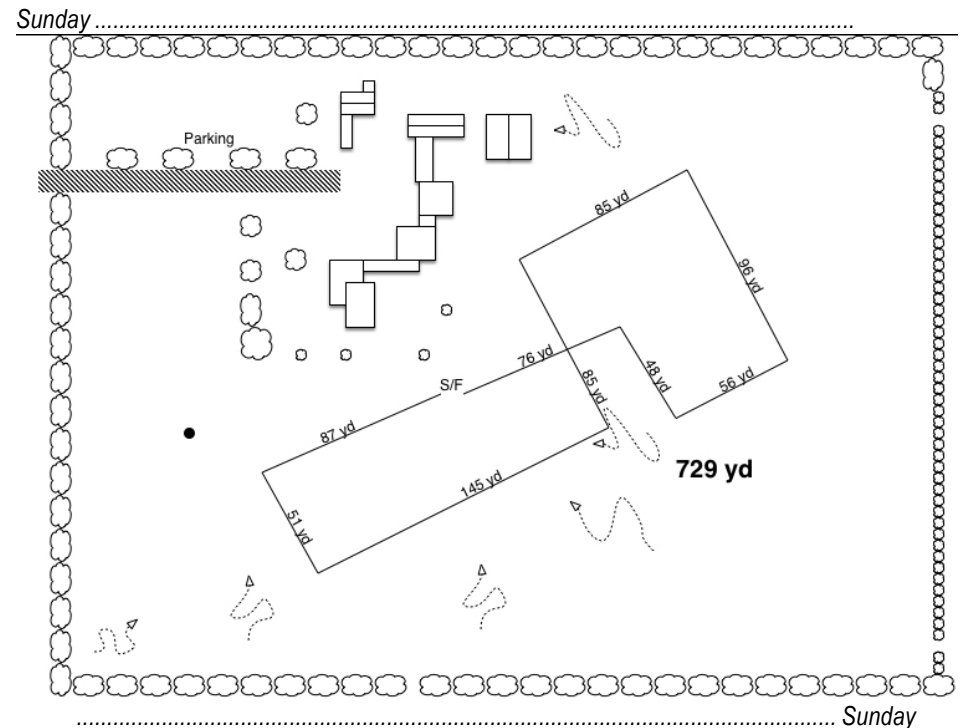
BEST IN FIELD WILL NOT BE OFFERED

Conditions of Entry

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified.

Course Plans

Gas- or battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of highly visible white or black plastic strips and/or fur strips • Course may be altered as required by weather or field conditions • Course will be reversed for finals • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.
