If using PayPal, please either send as "Friends and Family" or add \$2.00 per transaction. Include dog name(s), day(s) entered, and stakes entered.

**Regional Entry Fee (Saturday):** \$25 first entry/day, \$15 additional dogs from the same owner. Note that Early Entries are **required** for the Saturday Regional Invitational.

**Early Entries (Sunday only):** \$20 first entry/day, \$15 additional dogs from same owner.

**Day of Trial Entries (Sunday only):** \$25/entry, no multi-dog discount.

**Certification runs (Sunday only):** \$10. If you want to certify your dog and run in the Sunday trial, send in entries for a Certification run (\$10) along with an entry in Singles. If your dog passes the Certification run, it can be moved to the appropriate Open or Veterans Stake. **ONLY 5 CERT RUNS WILL BE OFFERED**, please send in a pre-entry to guarantee your dog's spot.

**TRIAL HOURS:** From 7:00 AM until after ribbons are awarded

**SATURDAY: TRIAL ROLL CALL 8:00 AM**

**SUNDAY: CERTIFICATION ROLL 8:00 AM, TRIAL ROLL CALL 8:30 AM or 10 minutes after the conclusion of cert runs, whichever is later.**

### **Entries will be acknowledged by email**

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. Property owners and the LLCC, or its members are not responsible for any accidents or injury at these trials.

***Rosettes will be offered by ASFA for all placements at the Saturday Regional Invitational.***

**On Sunday, Ribbons will be offered by LLCC for all placements.**

**First=Blue, Second=Red, Third=Yellow, Fourth=White, NBQ=Green**

**Highest Scoring Single=Navy/Gold, Best of Breed=Purple/Gold,**

**& Best in Regional=Red, White & Blue (Saturday only), Bench=Light Green,**

**Kennel and Breeder = Pink and Light Green**

***No Best in Field will be offered on Sunday***

## **ELIGIBLE BREEDS & REGISTRY FOR THE TRIALS**

### **Regional Invitational Eligibility (Saturday 12/18 entries):**

Any hound that is ASFA pointed or is pointed in its country of residence or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Provisional Stake. All points or placements must be earned by the closing date of the event. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes.

Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for greyhounds registered with the NGA.

### **REGULAR STAKES OFFERED**

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion.

**VETERAN STAKE:** Any eligible hound whose age is at least six years and has met certification requirements, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

### **NON-REGULAR STAKES OFFERED (Saturday Invitational only)**

**KENNEL STAKE:** For any two hounds – designated upon entry – of the same breed which are owned by and living with the same individual. Hounds must be entered in Open, FCh, or Veterans.

**BREEDER STAKE:** For any two hounds – designated upon entry – of the same breed which are bred or co-bred by the same individual. Hounds must be entered in Open, FCh, or Veterans.

**BENCH STAKE:** For any hound eligible to enter a regular stake (Open, FCh, or Veterans) that has a conformation champion title from the AKC, CKC, or both, or a conformation grand champion title from the UKC. A copy of the hound's championship certificate must accompany entry in this stake.



### CONDITIONS OF ENTRY:

- ⇒ All entries must be one year or older on the day of the trial.
- ⇒ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- ⇒ Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
- ⇒ Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
- ⇒ Hounds with breed disqualifications are not eligible to enter except in the Single Stake and LCI Stake.
- ⇒ Hounds not present at the time of roll call will be scratched.
- ⇒ All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- ⇒ **\$25 fine for returned checks.**

### OTHER:

- ⇒ LLCC and property owners assume no liability for any accident or injury to any person or dog before, during or after these Trials.
- ⇒ All animals on Trial grounds are expected to be current on vaccinations as required by New Mexico State Law.
- ⇒ There will be a \$5 fine assessed for any hound loose on the field, other than those running the course in progress. \$5 fine for delay of trial at judge's discretion.
- ⇒ Everyone must clean up after themselves and their dogs.

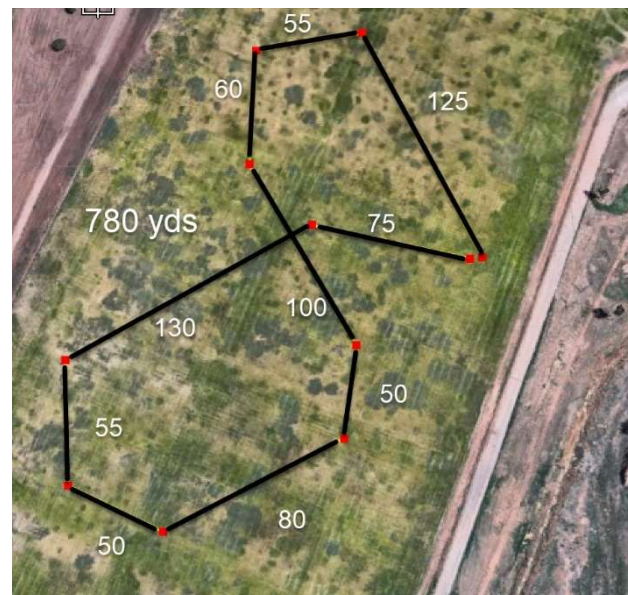

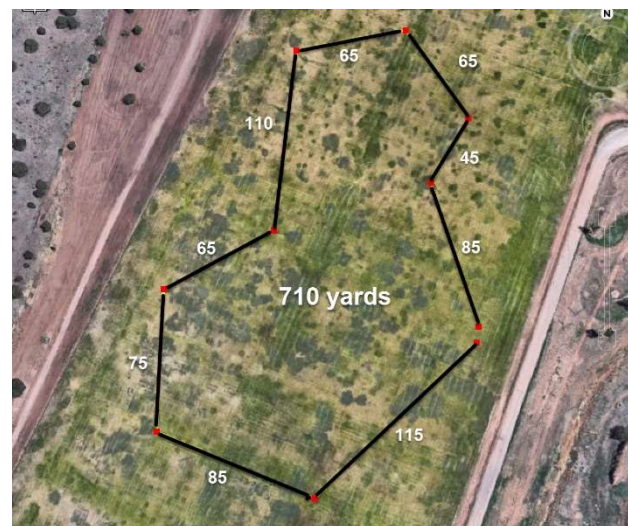

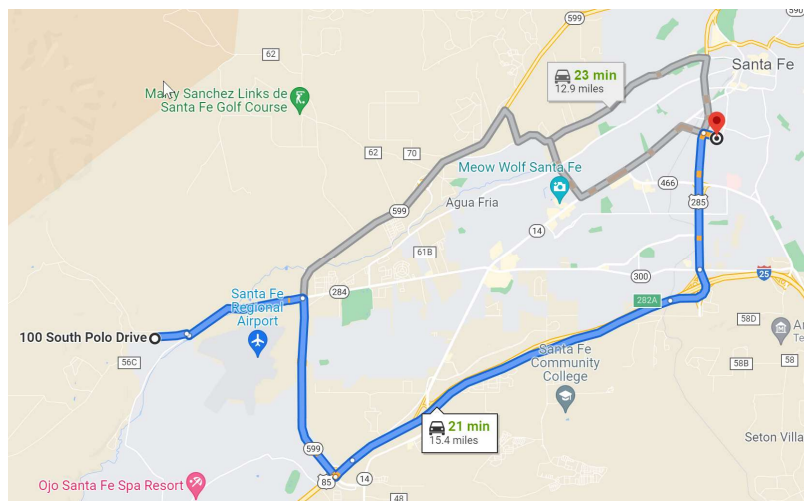

# Lure Chasing Instinct Program

**The Lure Chasing Instinct Program is for all dogs (both purebred and mixed breed) that are NOT eligible to run in Lure Coursing Trials.** See a list of ASFA lure coursing breeds above, under “ELIGIBLE BREEDS.”

**LCI dogs run twice** (in prelims and with the course reversed for finals). Dogs are evaluated by one or two judges in the following categories:

Enthusiasm .....	15 pts.
Follow .....	15 pts.
Speed .....	25 pts.
Agility .....	25 pts.
Endurance.....	20 pts.
Total .....	100 pts.

and earn Proficiency points for placements in their stakes towards ASFA Lure Chasing Instinct titles.

## To compete dogs must:

- Be a minimum of 12 months old
- Be physically fit for competition. Blindness, Lameness and Amputation are considered as being unfit
- Females must not be in heat/season
- Be free of bandaging or any other attachments for medical purposes
- Not be disqualified

## Requirements:

All dogs entered must have a registration number via one of the following:

- AKC Registration** as one of the recognized breeds.
- AKC Canine Partners**, which is for mixed-breed dogs and dogs ineligible for AKC registration.
- Purebred Alternative Listing (PAL)** program, which is for purebred dogs that cannot be fully registered with the AKC to participate in AKC events.
- Foundation Stock Service® (FSS)**, which is for recorded breeds on the road to full AKC recognition.
- United Kennel Club (UKC)** registration as one of the recognized breeds.
- If the dog has none of the above registrations, **ASFA will provide a unique entry number** for a one-time \$10 charge.

1. The owner has to complete an ASFA **Request for ASFA Lure Chasing Instinct Registration Number** (see form below)
2. The Trial Secretary will submit a copy of the form with the records.
3. The owner will retain a copy as proof of request and payment until permanent number is provided.

**The owner or agent entering a dog in a lure field trial does so at his own risk. The owner or agent and licensed club agree to abide by the rules of the ASFA.**

Entry fees shall be fixed by the host club and shall be forfeited in such cases where dogs are scratched from the field except for one of the following causes.

- Dogs determined to be lame at the time of roll call shall be barred from competition and their entry fees shall be refunded.
- Bitches in season, or bitches showing a discharge characteristic of being in season, or which come in season after the close of entries, shall be excepted from this rule and their entry fees shall be refunded. Notification to the Field Trial Secretary of bitches in season must be made before or during the roll call. Bitches known to be in season should not be brought onto the trial grounds and shall be removed if discovered to have come in to season.
- Dogs that have been disqualified for aggression by another organization. Fees will be refunded only if the owner or agent notifies the Field Trial Secretary of such ineligibility prior to or during roll call.

## LURE CHASING INSTINCT STAKES OFFERED

**LCI Entries: Check TWO boxes on the LCI entry form, one for Small / Large / Sighthound and one for Open / Senior / Veteran.**

**Small Open:** dogs 17-1/2” or less at the withers and / or brachycephalic (“flat-faced”) dogs who have not achieved the title of LCC.

**Small Senior:** dogs 17-1/2” or less at the withers and/or brachycephalic dogs who have achieved an LCC.

**Small Veteran:** dogs 17-1/2” or less at the withers and/or brachycephalic dogs over 7 years.

**Large Open:** dogs over 17-1/2” at the withers who have not achieved the title of LCC.

**Large Senior:** dogs over 17-1/2” at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound mix Open:** dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound mix Senior:** dogs with a sighthound breed in its background who have achieved the title of LCC.

**Sighthound mix Veteran:** dogs with a sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, **Small will run 50%** of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.
