Roll Call and Inspection: 8:30 am each day. Hounds not present at roll call will be marked absent and are not eligible for refund of entry fee.

Trial Hours: 7:30 am each day until one hour past the completion of the last scored course of the day.

Awards: Ribbons will be awarded for all placements - 1st through NBQ.

Eligibility Requirements

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Incomplete, unsigned, conditional, or late entries WILL NOT be accepted. Entry forms by minor owner/handlers (under the age of eighteen years) must be signed/co-signed by a parent or guardian. SLASH will not be responsible for accidents at this trial. ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL. Substitutes for lame or in-season hounds are allowed if substitute has same owner and the Field Secretary is notified at least one hour prior to roll call.

Any entry marked "First Time Entry" must be accompanied by a completed ASFA hound certification form (not required for entries in the Singles Stake). A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry (not required for first time entered NGA hounds.

Stakes Offered

Open	Any eligible sighthound that has met certification requirements, excluding ASFA Field

Champions of record.

Field Champion Any ASFA Field Champion.

Veteran Any eligible sighthound that has met certification requirements whose age is at least six

years, except Irish Wolfhounds whose age shall be at least five years and Afghans, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years.

Points go toward V-Fch or V-LCM titles.

Limited Any eligible sighthound of a Limited or Provisional stake breed that has met

certification requirements. Not eligible for Best of Breed or Best in Field.

Single Any eligible sighthound including those disqualified to run in other stakes. Not eligible

for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from


the Singles stake. Limited breeds are not eligible for these titles.

Best in Field Will be offered Saturday, November 18 ONLY


- All entries must be one year of age or over on the day of the trial.
- Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- Hounds not present at roll call will be scratched.
- Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Muzzles are not required. It is the responsibility of the owner to determine if their hound needs to be muzzled
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- Lure will consist of highly visible plastic strips.
- A fee of \$20 will be assessed for any returned checks.

- There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
- There will be a \$15 fine for any owner/handler who does not clean up after their hound.
- Course will be reversed for finals and again for run-offs and Best of Breed.
- Hound certification runs will be offered Saturday only following the trial pending condition of the
 equipment and weather.
- Persons exhibiting conduct detrimental to ASFA/SLASH/Purina/any hound(s)/other person(s) will be
 asked to leave the trial site.

Hound Certification Runs and Practice

Certification: Any entry marked *First Time Entered*, other than those entered in the Singles Stake, must present a completed ASFA hound certification form to the Field Trial Secretary BEFORE entries close. See the back of the entry form for certification forms and make extra copies if necessary. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry. This requirement is waived for hounds registered with the National Greyhound Association.

Certification runs will be offered at the cost of \$5.00 per run on Saturday only after the completion of the ASFA trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial. Current SLASH members may certify their hounds at no cost.

Limited practice runs will be allowed following the certification runs on Saturday, weather and equipment permitting. A sign-up sheet will be available from the Field Trial Secretary. There will be no practices following the trial on Sunday.

Directions to Purina Farms

From St. Louis or Springfield, MO

Take I-44 to the Gray Summit (Highway 100) exit. (About 20 miles west of I-270/St. Louis). Go north on Hwy 100 until you spot Hwy MM and the Purina Farms sign (approximately 1/2 mile). Turn left onto Hwy. MM and drive about 3/4 mile until you reach the Purina Sheep and Cattle Barns on your left and a silo on the right. Turn left to the cattle barns and Field is located right behind the barns. If you find yourself at the main visitors' gate for Purina Farms, you have gone too far.

From Kansas City

Take I-70 east to the Warrenton exit at Hwy. 47. Go south on Hwy. 47 for approximately 25 miles until you reach Hwy. 100 in Washington. Turn left onto Hwy. 100 and continue to I-44 (approximately 10 miles). Go east on I-44. Follow the directions above from Springfield.

NOTE:

Although the field is completely fenced, it is also used as a pasture for cows and sheep during the week. Water will be available for cooling hounds. Shade is limited. If conditions are muddy, parking will be confined to gravel parking lot and gravel roads.


