Directions to the Site:

From the North traveling South on I-5:

Exit Cottage Grove, 6th Avenue exit 172. Turn left and go over freeway. Follow 6th Avenue down the Hill and veer to the left. Sixth Avenue now has become London Rd. Follow directions for London Rd.

From the South traveling North on I-5:

Exit Cottage Grove exit 170. Follow road left over freeway and drive north, Parallel to the freeway for about 2 miles. Turn right on Latham Rd. Follow Latham Rd back under freeway until it dead ends at 6th avenue. Turn right onto 6th / London Rd. Follow directions for London Rd.

From Rice Hill (Exit 148 on I-5):

Exit Scotts Valley, exit 154. At the stop sign, go straight across, then bear right onto Scotts Valley Rd. Travel about 5 miles to the first and only left turn. This is London Hill Rd which becomes Shoestring Rd. Take London Hill Rd for about 5 miles (some parts are gravel), it is also narrow and curvy but beautiful. At the T junction you will be facing London Church. Turn right onto London Rd and Finish with directions for London Rd. (It will take about 25-30 min from exit)

Directions once on London Rd:

Follow London Road to mile marker 13. Right after mile marker 13 you cross a bridge (the 3rd bridge on London Road). About ¼ mile past bridge, there are 3 mail boxes on the right side of the road. Directly opposite the mail boxes is a dirt road (BLM sign on the far left corner). Turn left onto that dirt road, Follow dirt road about ¼ mile to the Y intersection. Bear left at the Y. Do not take the driveway immediately after the Y. Go straight until a stop sign and the Whippet Watch sign. Turn left right after the stop sign and follow the gravel road down to the field. Parking is right next to the barn or next to the horse pens. If it is wet, please park on the gravel drive as the ground in the pasture can get very soft.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE: Any ASFA Field Champion

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

BEST IN FIELD will be offered.

Conditions of Entry: All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

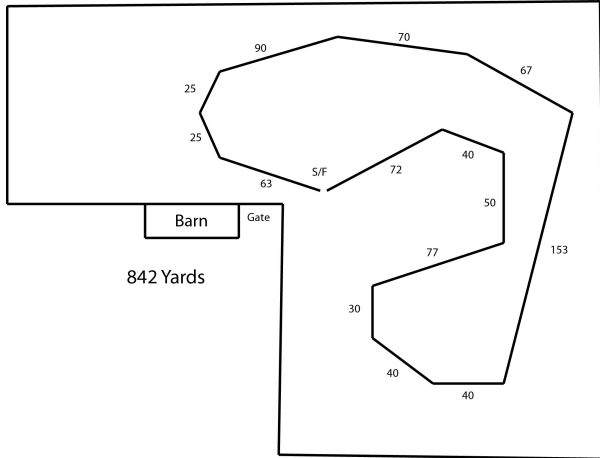

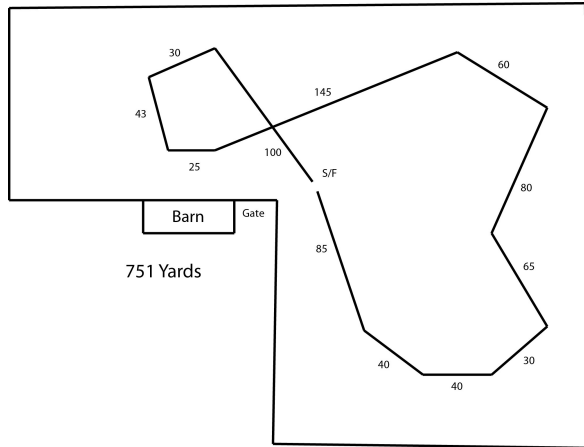
