ELIGIBILITY REQUIREMENTS

Only purebred Rhodesian Ridgebacks are eligible.

All entries shall be individually registered with AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL

STAKES OFFERED

Open Stake: Any eligible Rhodesian Ridgeback, excluding ASFA Field Champions of record.

Field Champion Stake: Any Rhodesian Ridgeback ASFA Field Champion of record.

Veteran Stake: Any eligible Rhodesian Ridgebacks whose age shall be at least seven years.

Points go toward V-FCH or V-LCM titles.

CONDITIONS OF ENTRY

All entries must be one year or older on the day of the trial.

Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.

Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.

Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.

Hounds with breed disqualifications are not eligible to enter.

Hounds not present at the time of roll call will be scratched.

All hounds will run twice, in trios if possible or braces, unless excused, dismissed or disqualified.

Hound certification runs will be offered following the trial, before practice and weather and equipment permitting.

Owners must keep their hounds under control and clean up after them.

PRACTICE

Will be held after the Trial is finished if weather, equipment and daylight permit.

Practice is \$5 per dog. Priority will be given to sighthound breeds.

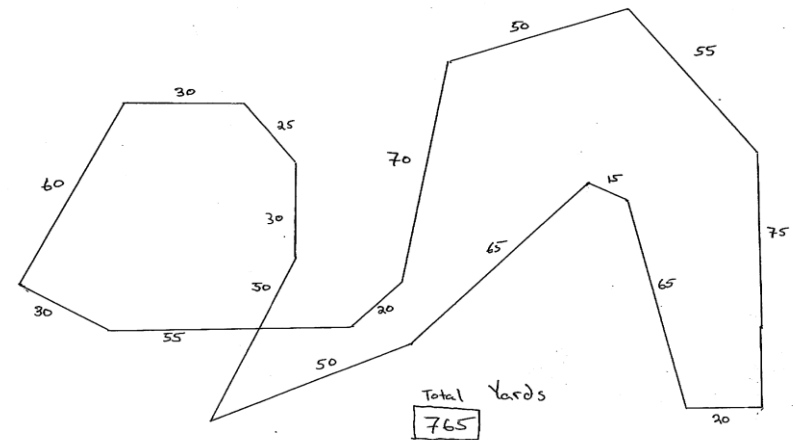
