



Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake) unless excused, dismissed or disqualified. Muzzles will not be required but may be used at the handlers discretion. A \$5.00 fine will be imposed for any loose hound on the field not competing in the course in progress. Club reserves the right to alter the course the day of the trial due to weather and/or field conditions. Owners must keep hounds under control and clean up after them. The course will be reversed for final courses, reversed again for Best of Breed, and Run-Offs. Certification runs will be offered after the trial.
