

Directions to the Polo Field, Camden SC

From the North: Follow 97/521/601 into Camden. Where it becomes Broad Street, after you pass the railroad tracks, turn Right onto Polo Lane. Follow Polo Lane to the field. Polo Lane is a very narrow street (about 1 car width). Watch for signs.

From the South: On Interstate-20 in South Carolina take Exit 92 onto US-601 North toward Camden. Travel about 5.5 miles, and turn LEFT onto 601 North Truck/ Springdale Dr (first traffic light past Wal-Mart). On 601 North Truck, travel past Springdale racecourse to the Hwy 97. Turn Right onto Hwy 97. Hwy 97 blends into Broad Street. On Broad Street, after you pass the railroad tracks, turn Right onto Polo Lane. Follow Polo Lane to the field. Polo Lane is a very narrow street (about 1 car width). Watch for signs.

### ELIGIBLE BREEDS & REGISTRY

Only purebred Silken Windhounds may be entered. All entries shall be individually registered with the UKC,  
an ASFA recognized foreign or ASFA Board approved registry, namely, the ISWS. A photocopy of  
acceptable registry must be submitted with each hound's first ASFA field trial entry.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Open to Silken Windhounds excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Open to Silken Windhounds that have earned their ASFA Field Champion title.

**OPEN VETERAN STAKE:** Open to Silken Windhounds that have reached 6 years of age on the day of the  
trial. Points and placements go towards the V-FCh and V-LCM titles.

**SINGLE STAKE:** Open to Silken Windhounds including those disqualified to run in other stakes. They are  
not eligible for Best of Breed or Best In Field. Hounds are eligible to earn TCP and CPX titles from the  
Single Stake. Limited breeds are not eligible for these titles.

### NON-REGULAR STAKES OFFERED

**KENNEL STAKE:** For two hounds of any breeder, designated at time of entry, as being owned and  
kennelled by the same person.

**BREEDER STAKE:** For two hounds, designated at time of entry, as being bred by the same individual.

**BENCH STAKE:** Entry shall consist of a single hound with a conformation champion title, designated at  
time of entry.

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into  
flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame  
hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid  
or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications  
are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be  
scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless  
excused, dismissed or disqualified.

**Equipment:** Type of lure machine: battery-powered continuous-loop system. • Type of lures: highly-visible  
white plastic strips • Back-up equipment will be available.

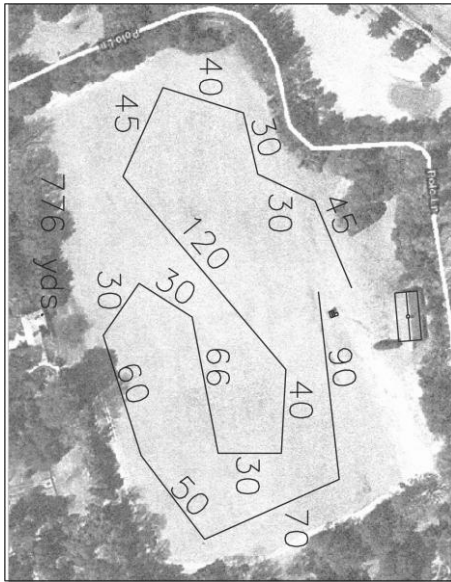
Only the Lure Operator, Huntmaster, Judges and Handlers of the hounds running in the course in progress  
will be permitted near the lure machine. The members of Carolina Lure Coursing Society reserve the right  
to alter the course plan as required by weather and/or field conditions on the day of the trial. The field will be  
reversed for finals, runoffs, Best of Breed and Best In Event.

There will be a \$5.00 fine for any loose dog that disrupts a course in progress.
