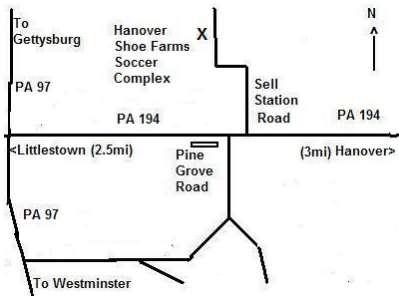
**Directions to Hanover Shoe Farms, Sells Station Road Site:**

### ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets.

Provisional breeds may be entered in the Limited Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

**LURE COURSING INSTINCT (LCI) STAKE:** Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Senior:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Senior:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

The **GRANDE PRIXE** is contested annually at the Upper Chesapeake Bay Saluki Club's All-Breed Lure Coursing Trials over both days of competition.

**GRANDE PRIX CHALLENGE CUP TROPHIES** are awarded to overall **Best of Breed(s)**

**BEST IN GRANDE PRIXE ELIMINATION TROPHY** is awarded to the **Best in Field Winner**.

### **BREED TROPHIES**

**DRAKULA Challenge Cup for Afghan Hounds:** Donated by Bob and Linda Jordan, Windcrest Afghans, in honor of FC Utchati Kount Drakula Qamari, LCM II, ORC

**BETTE Challenge Cup for Basenji:** Donated by Dave and Carol Phelps, Patrician Basenjis, in honor of Patrician Sheena Crimson Art, LCM III

**AURIUM Challenge Cup for Borzoi:** Donated by Diana Darling in honor of FC Mayberry's Aurium of Rhyka. Aurium was #1 Borzoi in ASFA, AKC, CKC, and Open Field in 1993, and is the only hound to have achieved this remarkable feat.

These Eastern Seaboard trials were conceived to provide a true test of our hounds' agility, speed and endurance on two separate course plans, each with a specific challenge. At the end of the two trials we will know the fastest, most agile, and enduring hound in each breed. They will be awarded the Breed Grande Prix Challenge Cups. All Breed Challenge Cup Winners will then be eligible to compete for the Best in Grande Prix Elimination Trophy.

## **RULES**

### **A HOUND MUST COMPETE ON BOTH DAYS TO WIN A GRANDE PRIXE BREED CHALLENGE CUP**

The Breed Challenge Cup Winner will be the hound that wins Best of Breed on both days. If the same hound does not win BOB both days, then the winner will be determined by a run-off between the BOB winner from each day, and also the hound which defeated the most hounds in its breed over the two days without winning a BOB. The Breed Challenge Cups are silver champagne coolers which honor the outstanding lure coursing hounds in each breed. They are retired to any owner who wins one three times.

All judges will judge the Grande Prix Perpetual Trophy elimination run(s) (if possible). A random draw will determine courses. Hounds winning each course will re-compete, until the **Grande Prix Perpetual Trophy Winner** is determined via elimination.

## Hanover Lure Coursing Procedures

We will follow State and local guidelines.

1. Facial Coverings are optional
2. No food will be served, bring your own breakfast and lunches. Sorry!!! Please bring your own food, water and shade for yourself and your dogs. None will be available at this time.
3. We ask that you park at a safe distance away from each other.
4. We will ask the owners of females to wipe their dogs and show the inspection committee the tissue.
5. Wickets will be wiped down after each dog.
6. We will have instant hand sanitizer and wet wipes everywhere.
7. We will prop open the porty pots when not in use for more air flow to cut down on bacteria.
8. Huntmasters will stand 6 feet from the dogs after inspecting blankets and slip leads.
9. At the starting line, all dogs will stand 6 feet apart.
10. Practice social distancing the best you can. I know we all have been cooped up but act responsibly!!
11. Please be aware of the running orders will be posted as usual.

Above all, have fun with your dogs and be safe!!!

## OTHER INFORMATION

- All entries must be one year or older on the day of the trial
  - Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
  - Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered.
  - Hounds with breed disqualifications are not eligible to enter except in the Single Stake
  - Hounds not present at the time of roll call will be scratched
  - All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Battery powered; continuous loop lure machines will be used. The lure will consist of white plastic strips. Backup equipment will be available. The course will be reversed for the finals, runoffs and Best of Breed.
- The members of UCBSC reserve the right to alter the course plan as required by weather and/or field conditions on the date of the trial. Exhibitors are requested to not bring bitches known to be in season to the field.

There will be a \$5.00 fine assessed for any loose hound not participating in the course.

Any person may, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Trial Committee.

The field is board fenced; camping is permitted, but there is NO electricity or water.

Children must be always under control of their parents or guardians.

**Field Setup**

◆ Come early (one hour before roll call) and start by carrying equipment.

◆ Learn as you go how to place pulleys and tie downs, eventually

**Field Clerk**

◆ Volunteer to help the field clerk for even one or two breeds

◆ Learn how scores are tabulated and recorded - when you are comfortable with this you will be able to start helping the field trial secretary.

**Runner**
