Trial Hours:

Sunday Sep 2nd & Monday Sep 3rd – "Day of" entries close at 8am. Roll Call at 8:15 am, draw and trial to begin immediately at the end of roll call. Check-in for dogs belonging to the field committee will begin 30 minutes before published trial hours.

Conditions of Entry:

All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall

be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

REGIONAL INVITATIONAL REQUIREMENTS

Any hound that is ASFA pointed, or is pointed in its country of residence, or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals.

Eligible to Enter: Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Stakes Offered:

OPEN STAKE – Any eligible sighthound that has met the certification requirements, excluding ASFA Field Champions of record.

FIELD CHAMPION STAKE – Any ASFA Field Champion of record.

VETERAN STAKE – Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE – Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE – Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Event. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.



Course Plan:

Terrain is PLOWED field with uneven ground. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used. Backup equipment will be available. Lure will consist of white plastic strips.

USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

Sunday's course is 710 yards and Monday's course is 600 yards, reversed for finals, BOB/BIE at judges' discretion.



Basic information about the weekend:

There will be a Port-a-John on site. Bring your own food, water and shade. No littering. Pick up after your dogs, and please haul your garbage off the field. There will be a fine for NOT leaving the field as you found it. Dry camping is available - NO hookups, NO open fires, and NO DUMPING. Please respect the property owner's crops and only park vehicles and walk dogs in designated areas.

USRCC welcomes spectators, but asks that all spectators and exhibitors adhere to ASFA and USRCC standards of conduct. Any spectator or exhibitor that behaves in an inappropriate manner will be asked to leave the trial site.
