## List of Breeds Eligible to Enter:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and

Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound’s first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

## Stakes Offered:

**OPEN STAKE** – Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE** – Any ASFA Field Champion of record.

**VETERAN STAKE** – Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**LIMITED STAKE** – Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE** – Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

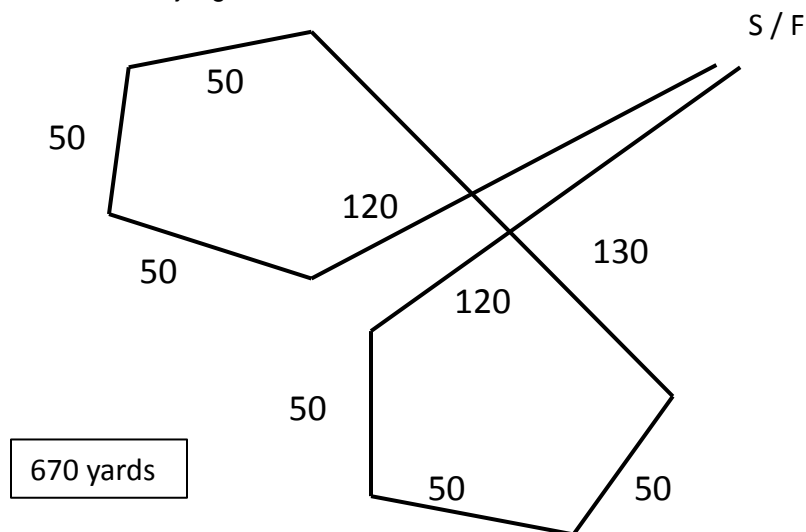
## Conditions of Entry:

All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call are not eligible to enter except in the Single Stake. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

### **Course Plan:**

Terrain is natural field with uneven ground. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used. Backup equipment will be available. Lure will consist of white plastic strips. USRCC reserves the right to alter the course diagram as required by weather and/or field conditions on the day of the trial.

The course is 670 yards, reversed for finals, BOB and BIF direction at the discretion of the judge



### **Basic information about the weekend:**

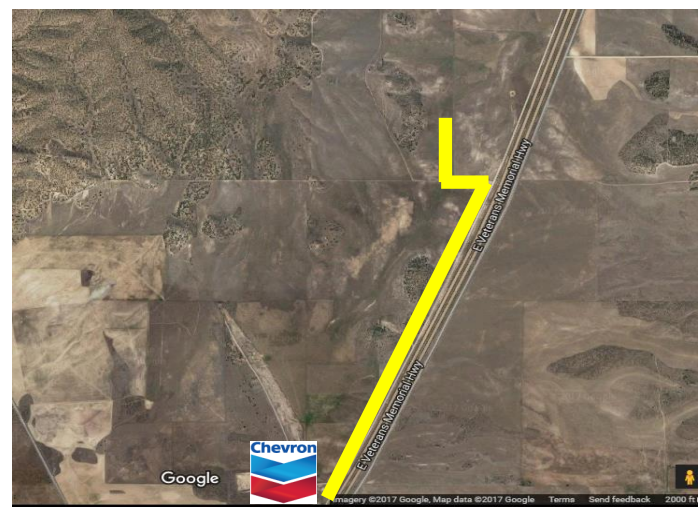
There will be a Port-a-John on site. Bring your own food, water and shade. No littering. Pick up after your dogs, and please haul your garbage off the field. There will be a fine for NOT leaving the field as you found it. Dry camping is available - NO hookups, NO open fires, and NO DUMPING.

USRCC welcomes spectators, but asks that all spectators and exhibitors adhere to ASFA and USRCC standards of conduct. Any spectator or exhibitor that behaves in an inappropriate manner will be asked to leave the trial site.

We will hold a potluck on the field Saturday Sep 2<sup>nd</sup> and a judges dinner in Fillmore Sunday Sep 3<sup>rd</sup>.

### **Directions to Onaqui Vista, Fillmore, UT :**

Take exit #167 on the north side of Fillmore. Head west, turn right onto the frontage road just before the Chevron. Head north on the frontage road for about 3 miles. On the left you will see an old tire hanging on the fence, turn left onto the road. Follow the road about 200 yards, turn right and follow the fence line to the field.
