Regional Invitational Requirements

Eligibility. Any hound that is ASFA pointed, or is pointed in its country of residence, or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

Trial Hours

Trial Hours: 7:00 AM until complete.

Trial Roll Call: 8:00 AM ALL BREEDS, early roll call for Field Committee.

Draw: Immediately following Roll Call.

Conditions of Entry

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered • Hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified. • Battery-powered continuous loop lure machines will be used, with backup equipment on site • The lure will consist of white plastic strips and/or fur strips • A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound. • Any person, upon reasonable complaint, be asked to leave the grounds of the field trial by the Field Committee and may be disciplined by the ASFA. • Children must be under control of their parent(s) or guardian(s) at all times.

Eligible Breeds and Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. Breed disqualifications apply.

All entries shall be individually registered with the AKC (ILP/PAL included) the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

CERTIFICATION/WAIVER REQUIREMENTS

All hounds must be certified prior to competing in an ASFA trial, except for the Singles Stakes. As time permits, hound certification runs will be offered Saturday afternoon. Certification runs will be \$5.00; forms must be complete.

If this is the first trial for your hound, your certification/waiver form and a copy of the hound's registration certificate MUST accompany your entry.

REGULAR STAKES OFFERED

OPEN STAKE: Any eligible sighthound, excluding ASFA Field Champions of record, which have met the certification requirements.

FIELD CHAMPION STAKE: Any ASFA Field Champion of record.

VETERAN STAKE: Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years which have met the certification requirements. Points go toward V-FCh or V-LCM titles.

LIMITED STAKE: Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

SINGLE STAKE: Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

NON-REGULAR STAKES OFFERED

KENNEL STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kennelled by the same person.

BREEDER STAKE: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, bred by the same individual.

BENCH STAKE: For any eligible sighthound with proof on file with the ASFA of a conformation championship title from the AKC, CKC or both, or a conformation grand championship title from the UKC.

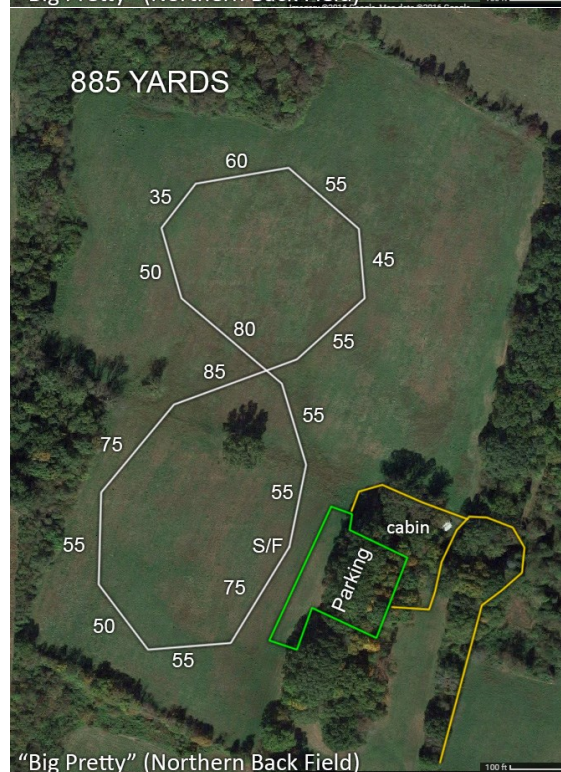

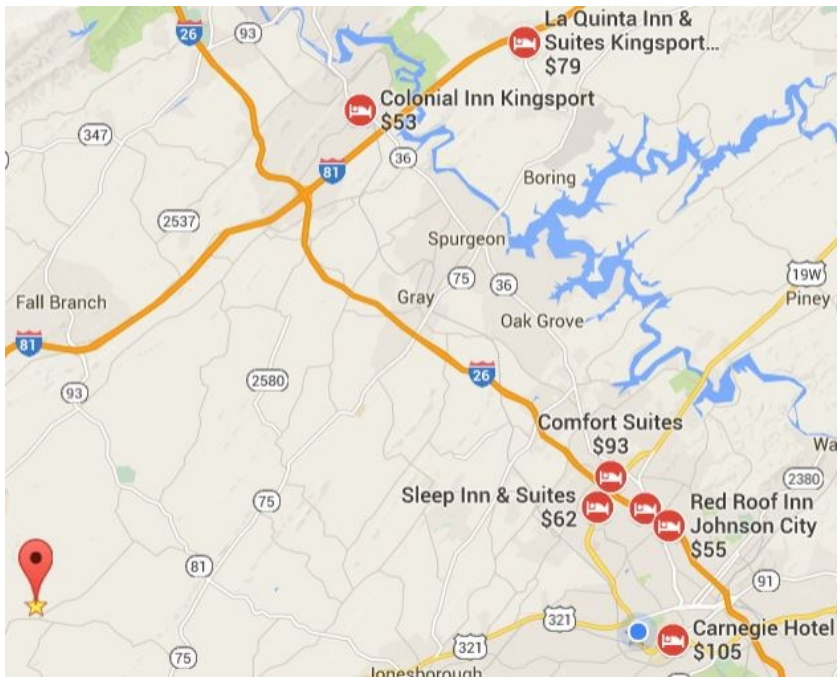

Directions—GPS/MAP TO “99 Glendale Rd., Limestone TN 37681”

Expect 20-30 minute travel times from most hotels. Google Maps works well. Verizon has the best cell coverage, but reception on the field may be spotty. Keep an eye out for the white vinyl horse fencing.

From I-81 (N, E, W) (12 mins): Take exit 50 for TN-93 south for 1.8 miles. Continue straight onto TN-81 for 2.2 miles. Right on Cherry Hill Rd for .6 miles. Bear left to Martin Rd. for .9 miles. Right on Glendale for 2.7 miles.

From I-26 (S) (40 mins): Take exit 37 north on TN-107/TN-81 for about 22 miles. Follow signs for TN-81N through Jonesborough. After passing the Marathon, keep an eye out for a sharp right turn, where you'll continue straight onto Pleasant Grove Rd. for .8 miles. Turn right onto Glendale Rd for 3.4 miles.

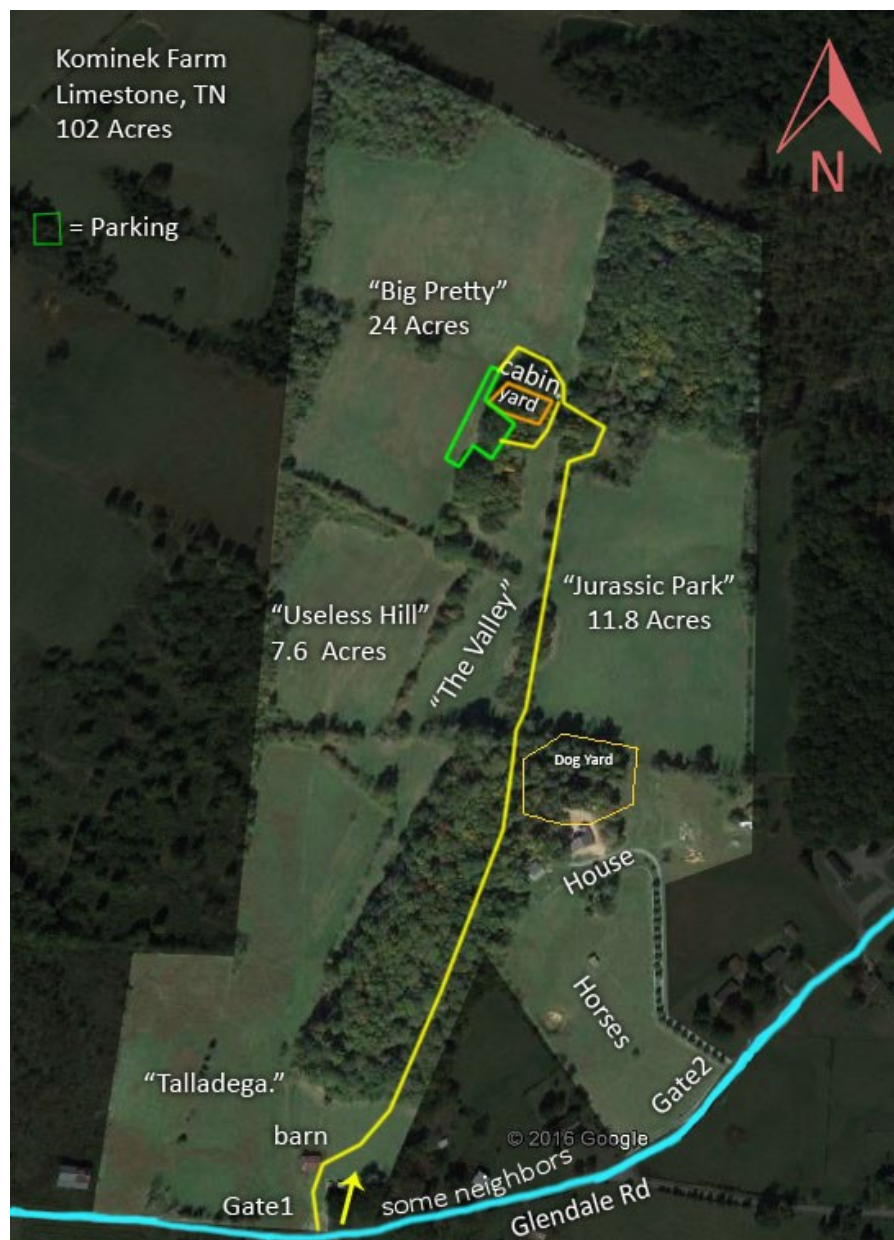

For the back field, "Big Pretty," you will enter Gate 1 which is a bit further down Glendale, 99 Glendale Rd. if you're using GPS. Signs will be posted for direction. Stay on the Gravel drive. RV's will be able to make it out to the backfield, but we plan on having shaded areas for the RV's and some cars to park in off the field. In case of loss of traction, a tractor and loader will be on hand for assistance. Significant improvements have been made to the property since the June trial including a straighter path, gravel the entire way and more shaded areas.
