

Any hound not present at roll call will be scratched and entry fee will not be refunded.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), and Portuguese Podengo (Medio & Grande) and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

ELIGIBILITY FOR REGIONAL INVITATIONAL (Sunday):

Any hound that is ASFA pointed, or is pointed in its country of residence, or is AKC pointed, is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Limited breed to be eligible, the entry must have one first placement, or two second placements, with competition in the Limited Stake. All points or placements must be earned by the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR TELEPHONE. LATE, INCOMPLETE, UNSIGNED OR CONDITIONAL ENTRIES WILL NOT BE ACCEPTED. ENTRIES PAID VIA PAYPAL MUST BE SIGNED AND EMAILED TO THE FTS.

STAKES OFFERED:

<u>OPEN</u> - Any eligible sighthound, excluding ASFA Field Champions of record, that has met ASFA certification requirements.

FIELD CHAMPION - Any ASFA Field Champion

<u>VETERAN</u> - Any eligible sighthound which is 6 years or older on the day of the trial, except Irish Wolfhounds whose age shall be 5 years; and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least 7 years of age and has met ASFA certification requirements

<u>SINGLE</u> -Any eligible sighthound, including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

<u>LIMITED</u> - Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

BEST IN FIELD WILL BE OFFERED SUNDAY ONLY.

GENERAL INFORMATION

<u>Conditions of Entry</u>: All entries must be one year or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake. Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

EQUIPMENT: Type of lure machine: battery-powered continuous-loop system. Back-up equipment will be available. Type of lures: highly-visible plastic strips.

A \$20.00 fee will be assessed for any returned checks. Persons exhibiting conduct detrimental to ASFA/CLCA/ any hound(s)/other person(s) will be asked to leave the trial site.

There will be a \$5.00 fine for any owner who does not clean up after his/her hound.


A penalty of \$5.00 will be assessed for any loose hound not competing in the course in progress.



CERTIFICATIONS AND PRACTICES will be held <u>AFTER</u> the trial on <u>SATURDAY</u>, WEATHER AND MACHINERY PERMITTING.

All hounds will be inspected before running. Lame hounds and bitches in season may NOT run.

Certification: Before entering a regular ASFA trial, any entry marked "First ASFA Point Trial" must have an ASFA Hound Certification form and a copy of the hound's registration papers (not required for NGA greyhounds) and must present them to the Field Trial Secretary along with your entry. This applies to "First ASFA point trial" hounds entered in the OPEN, VETERAN or LIMITED stake. Certification forms will be available, but MUST be completed prior to judging. Also have your hound's registration number available for the Certification form.

Certification: \$7.00. Owners wishing to certify a hound for competition are responsible for arranging for a hound of the same breed, or similar running style, to run with his/her dog for the certification.

Practices: \$5.00 each dog

Plan on arriving to the field around 11:30a.m.; arrive earlier if you wish to see the competition. Certifications and practices will not be run earlier than 11:30a.m., but may be held much later depending upon the entry in the trial.
