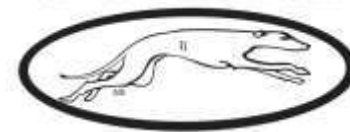

## **ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breed: Silken Windhound.

Limited breeds may be entered in the Limited Stake or the Singles Stake. Limited breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

**\*\*REFUNDS - GANG** will issue a refund of entry fees for dogs that are in season or lame, If your hound comes in season or becomes lame before the Trial, and you will not be attending Trial for these reasons, you must call the Trial Secretary BEFORE Roll Call – otherwise you forfeit your entry fees!

### **CONDITIONS OF ENTRY:**

**All entries must be one year or older on the day of the trial**

- **Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more**
- **Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call; hounds with breed disqualifications are not eligible to enter except in the Single Stake**
- **Spayed, neutered, monorchid or cryptorchid hounds may be entered**
- **Hounds not present at the time of roll call will be scratched**
- **All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.**

### **ADDITIONAL CONDITIONS:**

- Hounds not present at time of Roll Call will be scratched and entry fees will NOT be refunded.
- Battery-powered, continuous loop lure machines will be used with back-up equipment available.
- The lure will consist of light and/or light colored plastic
  - Muzzles are not required: It is the responsibility of the owners to determine if the hound should be muzzled

## **IMPORTANT Facility Information**

This trial will be held at Chattahoochee Hills Eventing. CHE is an 8,000-acre equestrian eventing estate that run 12 miles along the Chattahoochee River. Convenient to the Atlanta Airport and downtown Atlanta.

## **REGULAR STAKES OFFERED**

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks and Whippets whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**LIMITED STAKE:** Any eligible sighthound of a Limited breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLE STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Limited breeds are not eligible for these titles.

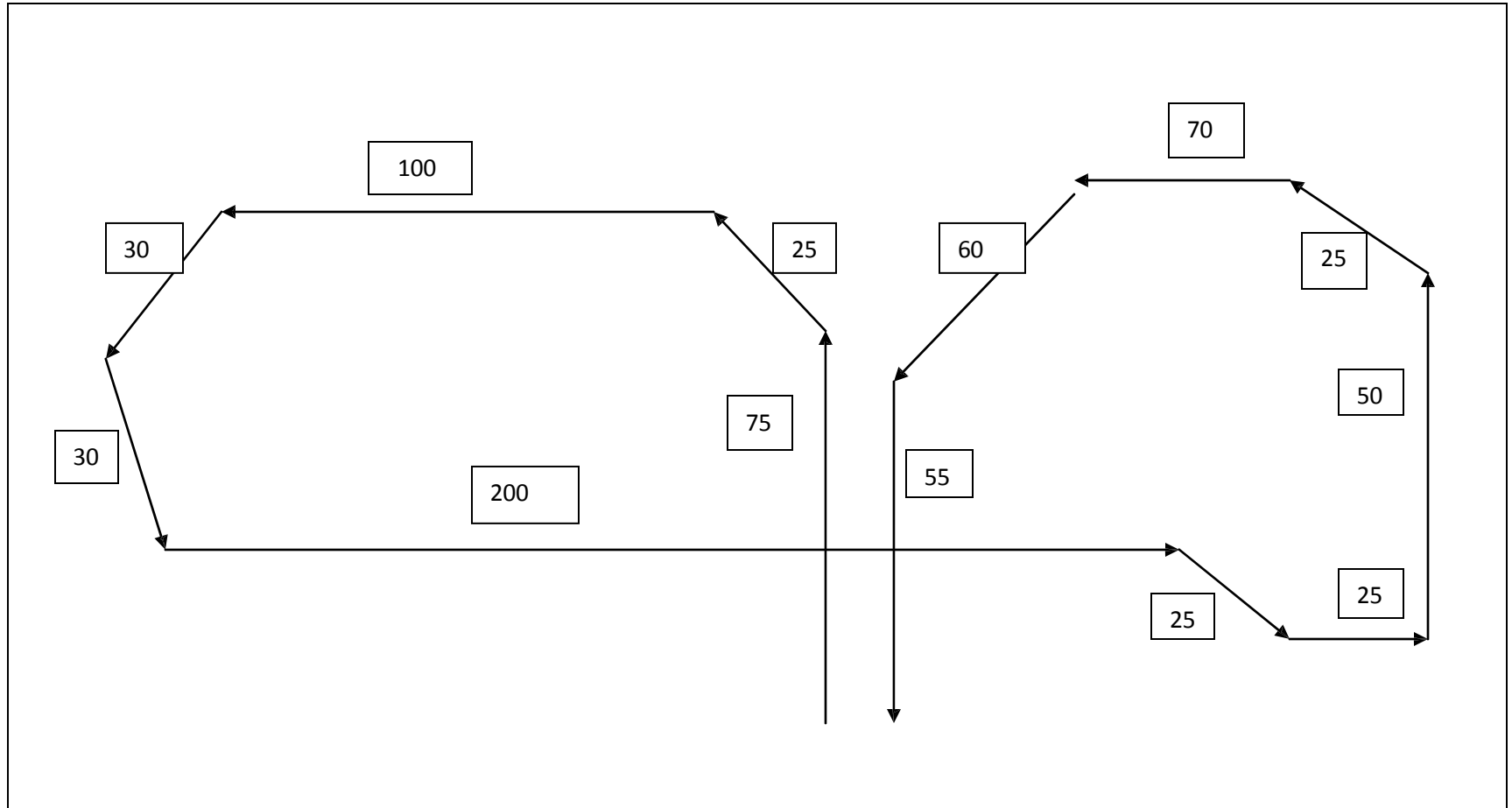

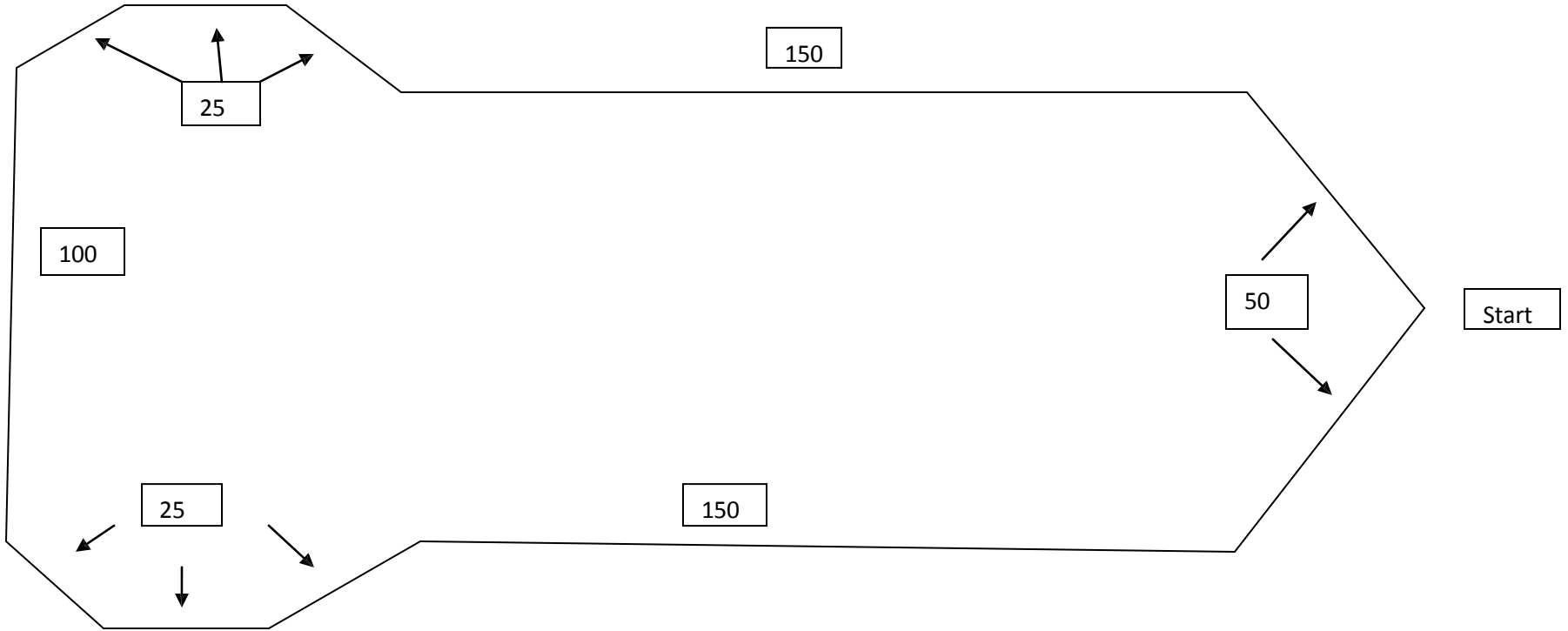
