She was an Open Field Courser of Merit (vs Afghan Hounds) and an Open Field Coursing Champion (vs all breeds) and is the All-time Top NOFCA Open Field Afghan Hound.

## the deadline has been extended to February 17th



This is how it works. All nominees – hounds and persons - must have been out of the sport for at least 5 years to be considered. Hound nominations are made through the ASFA clubs. Persons are nominated through the Regions. So, to nominate a hound, you will need to work through your club. To nominate a person, you will need to work with your Regional Director.

The Hall of Fame Committee will select up to 5 nominated hounds and 3 nominated persons to present for consideration at the 2024 ACoD. The ACoD Delegates will then vote to induct 1 person and up to 3 hounds into the Hall of Fame.

Direct all questions and all nominations to Michael Hussey at <u>dinnree@skybeam.com</u>. The ASFA Hall of Fame Committee nominations for the current year are now open and will be voted on at the 2024 Annual Convention of Delegates.

At this time, I have no new hound nominations for 2024 or person nominations. Nominations must be made on the official forms that are available (in both PDF and Word) on the ASFA website under RESULTS AND AWARDS/HALL OF FAME/NOMINATIONS.

#### **GARY FORRESTER AWARD NOMINATIONS**

Nominations should be sent to Michael Hussey (email addresses below). Nominations must be received by <del>January 15, 2024</del>, for consideration at the 2024 ASFA ACoD. I will extend the deadline to February 17, 2024. Please include a writeup detailing the nominee's ASFA lure coursing contributions, achievements, and a photo.

#### **EVALUATING NOMINEES**

The committee will give preference to people who have been active and involved with ASFA lure coursing for five years or more and who have made a long-lasting, significant, and positive impact on the sport and/or association. The committee will consider, but not be limited to, the following areas of involvement: a) lure field trial participation, b) judging, c) active leadership at the local level-clubs and trial activity, d) ASFA administration, e) promoting ASFA and the growth of the sport, f) improving the quality of trials, and g) exceptional performance or effort in any other area.

Ideally, the committee will name one recipient per year, but there may be good reasons for exceptions. It is possible there may be two or more equally deserving candidates or a team and naming one person might prove to be nearly impossible. Conversely, there may be a year when the committee cannot agree on any recipient. A person who is not currently a member of the board or an active key committee chair will be given strong preference. This award should not appear to be an "in house" honor.

#### SELECTION COMMITTEE PROCESS

An active Selection Committee of three people will make the choice rather autonomously. The committee members are chosen by the ASFA Board of Directors. Selection Committee members represent all areas of the country. The Selection Committee Chair is tasked with aggressively seeking nominations from the members of the ASFA board, from key ASFA committee chairs, and by request in the Communiqué.

The Selection Committee will review all nominees (maintaining a file of past nominees to be reviewed each year with the new nominations), make a choice, and then report the choice to both the winner and the ASFA Board no later than February 21, 2024. This will allow the recipient time to arrange to attend the ACoD, if they wish to do so. ASFA will offer to cover

the cost of convention registration fees (only) as a small incentive to encourage the recipient to attend. All members of the Selection Committee must agree on the winner. Written Information about the recipient, including their major accomplishments, will be supplied by the Selection Committee Chair to the ASFA webmaster and the presenter of the award at the ACoD.

It is time to prepare for ASFA's Annual Convention of Delegates (ACoD). This year's ACoD will be held in Memphis, Tennessee on the weekend of March 23rd and 24th. Each ASFA club can send two voting delegates to the ACoD as well as non-voting observers.

Attending the ACoD will give you an opportunity to become involved in ASFA and to participate in managing the direction of ASFA. It is also a good time to learn about ASFA, exchange information, get together with old friends, and meet new friends.

ASFA is a grassroots organization made up of member clubs. The clubs have direct input on the direction of the organization. Through the ACoD you, as a club delegate or observer, will learn what is happening within ASFA lure coursing around the country. You will be able to present ideas, ask questions, and gain information during the meeting.

Important business at this year's ACoD will include the election of the executive members (officers) of the ASFA Board of Directors.

Also, the ACoD is where changes to ASFA's constitution, rules, and policies are considered, discussed, and voted up or down by the delegates. The delegates will also discuss and vote on new business that is brought before them. Matters that come before the ACoD are brought by individuals through their clubs, either directly, or through their regions and/or the ASFA Board. And some matters that could not be completely resolved at a previous ACoD are brought back for further consideration and resolution.

# ASFA Board of Director OFFICER CANDIDATES

The officer nominee profiles were first published in our previous issue of November 2023 .





Being president of the ASFA has been an honor. Before being elected president in 2022, I served on the board as First Vice President and CFO. I earned my all breed coursing judging license in 1982.

As you may be able to guess, the demands of my full-time position have limited the time I have been able to devote to the ASFA.

At the end of 2017 I retired from my full-time job as a design engineer. For close to 2 years, I enjoyed traveling, judging, and showing my dogs.

In mid-2019 my ex-employer contacted me about coming back to run the company. After several discussions I agreed to return as an interim general manager while a search was conducted for a permanent company president. Covid hit full force in early 2020, and it was a full scramble to keep the company in operation. The consequence was that my 1 year gig turned into a permanent position. Finally, in Aug of 2023 I submitted my notice to retire as of January 1, 2024.

Leading a volunteer organization is a challenge. In the ASFA's case it is complicated by the structure of our constitution and Running Rules. After 50 years the accumulation of rules and policies makes change complicated and slow, as each new idea must be weighed against what can and cannot be done.

There is a benefit in this structure, as changes require careful consideration, limiting potential catastrophic consequences. On the other side is the problem that this structure makes it difficult to adapt to changing times and circumstances.

The ASFA organization is a committee-based system, with the board overseeing progress. Two years ago, when I first became president I did not recognize the effort needed to get all our committees populated. This resulted in a slow start, but we eventually caught up.

I feel strongly that if re-elected I will be able to devote significantly more time and effort to continuing the progress the ASFA has made. — Phil Fullam

# Message from President Phil Fullam

The change in the Scheduling Chair fortunately did not have any serious consequences for ASFA as Scott Hurlbert has taken over the responsibilities on a short term basis. A committee was established to search for a long term replacement and by the time the Communiqué is published will have made a recommendation to the Board.



At the virtual Board of Directors meeting in December, Las Vegas was selected as the potential location for the 2025 ACoD. The environment for holding conventions has become much more complex over the past several years. With the increase in costs for travel and lodging it is becoming a hardship for many clubs. The value of an in-person convention is great for renewing acquaintances and developing new relationships. The informal discussions help us to better understand each other.

It has been suggested that a hybrid format be developed, one in which an in-person venue is the primary, but member clubs could also participate virtually. A concern has been that this would reduce the number of delegates who would attend the in-person event and could create financial liability for the ASFA. I would argue that increasing involvement of member clubs is very important. Having more discussion and a broader representation can only improve the ASFA.

On a personal note, I have stepped down from my full-time position as President of Reytek Equipment LLC as of January 7, 2024. My role now is to mentor and assist my replacement over the next few months. I am looking forward to not going into the office every day.

Hope to see everyone in Memphis in March.

ASFA has had a decent year in 2023. We have had increases in the number of hounds that entered our trials, including new hounds. But they are not entering as many trials as previously. We have plateaued or even dipped in total trial entries. We continue to look at the causes. It is safe to say there is not just one cause.

There are a number of activities for our hounds to participate in and the cost of event locations has gone up across the country. I would challenge the clubs to try to host one more weekend of lure coursing a year and to work to do events in conjunction with other dog club activities.

With all that said, ASFA has had a minor dip to our checking account compared to last year. This is expected since 2023 was the first year we had an in-person ACoD since 2019.

While the final financial results of the International Invitational have not been compiled, there was a hit to our budget for the board hosting the event. I look forward to attending the II in Iowa on October 5-6, 2024.



# Excusal, Dismissal & Disqualification

Question

What are the differences between excusal, dismissal, and disqualification?

Answer

Our two Answers are from Greg Breitbach and Dean Wright.



**Greg Breitbach** *Greg has decades of experience on the field as a handler, huntmaster, lure operator, and judge. He is also the ASFA First Vice President (VP1), Judges Committee Chair, and Judges Licensing Committee Chair.* 

Excusal, Dismissal and Disqualification are three types of discipline described in the ASFA Running Rules. To start the discussion, I have pulled from the rule book the associated chapter/section for each reason. The rules are as follows:

#### Excusals:

**Chapter II, Section 2, paragraph 9:** [The Field Trial Chairman may,] . . . at his discretion, excuse from the field for the day, any hound that exhibits uncontrolled aggressive behavior toward any person or hound on the trial grounds, except hounds competing in the course then in progress. The Field Trial Chairman may also excuse or levy a fine and collect a . . . penalty fee . . . [for] any hound that is loose on the field and not in competition at the time.

**Chapter III, Section 12:** A zero total score from both judges, or a judge when only one is used, in the preliminary course automatically excuses a hound for the day. Hounds excused for any reason in the preliminary course will not be permitted to run in the final course and will not be counted as having been in competition when computing the points. Hounds scored in the preliminary run but excused in the final run shall be counted when computing points.

**Chapter III, Section 15:** In the event that a hound running loose joins a course in progress and interferes with or instigates a fight with another hound properly entered in that course, the judge or judges currently judging the course in progress may excuse the offending hound from the field for the day. (Such judges need not be scheduled to judge the breed to which the offending hound belongs.)

**Chapter III, Section 13:** Hounds may be excused from the field by a judge for the following reasons:

Hounds who fail to run after the tally-ho in either the preliminary or final course.

Hounds who may be considered unfit to compete.

Hounds who course other hounds rather than the lure.

Hounds whose owners or duly authorized agents interfere with the judges or officials.

Hounds who delay the course.

Handlers who willfully interfere with another competitor, his hound, or any official.

Q & A

Excusal, Dismissal & Disqualification

(continued)

#### Dismissal:

**Chapter VIII, Section 1.** Hounds shall be dismissed from the field by a judge, for the day, for interfering (aggressively or playfully) with the course of another hound. (Growling and/or barking, in and of itself, does not constitute grounds for dismissal.)

#### Disqualification:

**Chapter VIII, Section 2**. Hounds shall be disqualified by the judge, or by agreement of both judges where two are used, for the following reason: fighting - the aggressor in fighting in the field. In the event that only one of two judges disqualifies a hound, this disqualification constitutes a dismissal. Hounds disqualified by any other lure coursing organization shall be considered disqualified by the ASFA.

**EXCUSAL** As you can see, several chapters and sections are used to define what constitutes an excusal.

Excusal is the lowest form of discipline. Throughout the rulebook, multiple reasons are provided for excusal. The result of an excusal is that the hound cannot compete for the remainder of the day. The hound may return the next day, and nothing goes on the hound's official record. The item which needs to be further explained is "course other hounds" as this can be confused with potential interference.

Coursing another hound is generally defined as following another hound turn for turn and never attempting to pass that hound. No contact is made by the hound, but either that hound is concerned about the other hound or not confident enough to take the lead. This happens with new dogs who have not been practiced enough or have been interfered with in a prior course by the other hound. Generally running more practices and running with a hound that it knows will provide the confidence needed to overcome this situation.

During certifications, judges watch closely for this. That is why it is important when selecting a hound to certify with, that the owner of the certifying hound does not choose the fastest or most experienced hound to run with. Lure operation, especially at turns, can assist the judges in determining whether a hound is coursing another hound and is just being slow or timid.

**DISMISSAL** is the next level. This is where a hound actively tries to interrupt the course of either one or both of the other hounds in that course.

What is interference? It occurs when a hound is trying to knock another hound off the course or intimidate it by body checking. It is actively preventing another hound from being caught by its handler after the course is over.

One thing everyone must be aware of when it comes to body checking is when and where on a course this occurs. At times at the beginning of a course, the hounds may jockey for position and bumping will happen because each one wants to be in their preferred position which does not always happen with random draws. This usually occurs within the first 30 yards of the lead out.

When the hounds have gone some distance and one then moves over and slams into another hound or is in the lead and slows down to bump another hound, this is interference.

Sometimes on corners, hounds are not paying attention to their position and will bump into another hound in the course. Usually there is no head or body interaction prior to this occurrence. This is not viewed as interference. But when a hound slows at a corner, overshoots, or undershoots the corner and changes its angle which then bumps another hound off the lure or its path, it can be viewed as interference. This will usually occur more than once during a course.

Judges must be careful in this situation to avoid trying to read possible intent into any of the hound's actions. We cannot read the hound's "mind" in these situations. Accidents do happen on the field and should be viewed within the context of the entire course.

A dismissal does not prevent a hound from participating in further events., however two dismissals within six trials constitute a disqualification. Dismissals are expunged from a hound's record upon completion of six trials with competition and qualifying scores and no further detrimental actions by the hound.

**DISQUALIFICATION** is the most severe discipline. It is used when one hound aggressively attacks another hound anytime during or at the end of the course. Usually this involves actual biting of the other hound and not just bumping or jousting.

The huntmaster is very crucial at the end of courses in this regard. A judge's view may be hampered by handlers retrieving their hounds and any aggressive behavior towards another hound may not be clearly seen by the judge.

The huntmaster needs to know the difference between hounds going after the same lure and a hound aggressively pursuing another hound. If the judge(s) are not certain what happened, they should call the huntmaster, asking for an unbiased review of what the huntmaster saw, being careful about not leading the huntmaster's statement.

A disqualification prohibits a hound from running in competition with other dogs in further events unless or until it is reinstated. Disqualification requires retraining and the steps to be taken to reinstate the hound are defined in Chapter VIII of the running rules. -Greg Breitbach



Dean Wright has decades of experience on the field as a handler, huntmaster, lure operator, and judge. He is a Past President of ASFA. Dean has written many articles on ASFA and lure coursing. Dean has written for us previously on this subject in the past and reprises some previously published comments here.

ASFA recognizes three levels of interference between hounds running a course. These are: Innocently following another hound; actively interfering in another hound's pursuit of the lure; and attacking a hound during a course. The following are my personal comments and conclusions about these situations.

#### **TROUBLE**

**To Excuse** – An excusal is the mildest of ASFA consequences for hounds that interact with each other during a course. The hound at fault follows the other hound into every turn, rather than following the lure.

This kind of tag-along following happens often if a new hound is not slipped quickly on the "Tally Ho" and is behind a leading hound. This novice hound never sees the lure and relies on the other hound to lead the chase.

Sometimes, when approaching a corner, the leading hound cuts the corner and overruns the string. When that happens, the lure operator may well be able to let the inexperienced hound see the lure. Hopefully this will get the new hound back on the lure. The judge may or may not stop the course.

An Excused hound may not return to the trial that day.

**To Dismiss** – A Dismissal is the middle-level of consequences for interaction between dogs in a course. In this case, the hound at fault is not only following the other hound but catches the other hound and intentionally interferes with the hound that is following the lure's course. It may be playful or aggressive, but in any case it spoils the other hound's run.

A Dismissed hound will run under the shadow of Dismissal for five additional trials. He or she must run five trials without interfering. A second dismissal within five trials results in an automatic Disqualification. When a hound is working off a Dismissal, this must be indicated on the entry form.

**To Disqualify** – A Disqualification is the most serious of the consequences ASFA assigns to dogs interacting during a course. "A hound shall be Disqualified...for the following reason: fighting – the aggressor in fighting in the field." The hound at fault aggressively chases after the hound following the lure and starts fighting. If the hound that was attacked retaliates in self-defense that is not their fault and he or she is not penalized.

A Disqualified hound has lost the privilege to compete. <u>See</u> the ASFA Rule Book, Chapter VIII, Section 7 for reinstatement procedures.

#### TRAINING

After writing about consequences, I realize I need to write something on training your hound to prepare for their First Field Trial.

One of the worst things that can happen to a sighthound is to be entered in a trial with no previous practice. Every hound needs to run alone when practicing for the first several times. Once a new hound is keenly focused on the lure, we should also practice with a seasoned hound to run with this hound for the first time. When the new hound has passed these markers, he or she can earn the ASFA Certification of Eligibility.

The Hanover clubs, and many other ASFA clubs, hold practice sessions after the completion of the first day of a trial series. Many club members enjoy practice and are ready to help novice hounds and handlers get started.

One useful tip is to practice the start. Arrange with your friends and the practice crew to have a double "Tally Ho." At the first "Tally Ho" you slip your newbie immediately, the huntmaster cries "Tally Ho" again and the second hound is released. This exercise allows the inexperienced dog to have a clear sight of the lure even when he or she is not alone at the start.

If there is any question about whether the new hound chased the lure or the other hound, keep practicing. The best practices for this issue are not by themselves. Too much running alone sometimes makes the hound possessive of the lure.

The Singles stake is also a useful way to let new dogs become familiar with field trials.

## SOME RANDOM THOUGHTS ON TRAINING A PUPPY

<u>6 weeks</u> – Play with lure toy. A fishing pole with garbage bag attached. Let puppies chase as you pull it along the ground. Both in groups and as single puppies one at a time.

<u>3 months</u> – Take your pup to a trial or trials. Let him or her listen to noises and other people as well as the lure machine. Let puppies watch the lure especially as it goes through the machine and back out to start again. It's pretty exciting!

<u>6 months</u> – Take them to a trial and let him or her run a straightaway, with the crew reversing the wheel and so the pup can chase back to the start.

<u>9 months</u> – Take them to a trial and do a couple of turns, reverse and bring them back to the starting spot.

<u>11 months</u> – Take them to a trial and let run the entire course alone so it does not add the stress of trying to beat another dog.

12 months – Try a run with another hound, preferably an older hound that the pup knows. This experienced hound must be 110% on the lure.

<u>12 months</u> – Do a Certification run. – Dean Wright




# #1 LCI Small ASFA 2023


# Highlights from the 40<sup>th</sup> Running of the Allegheny Derby




