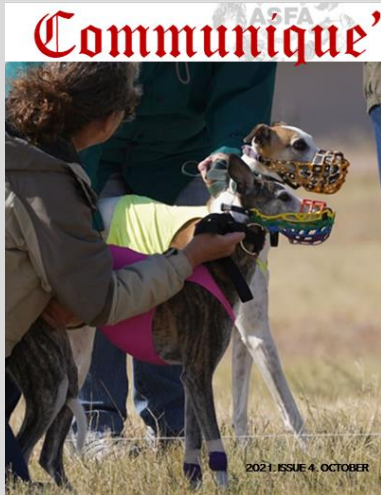

## INTRODUCING THE CANDIDATES

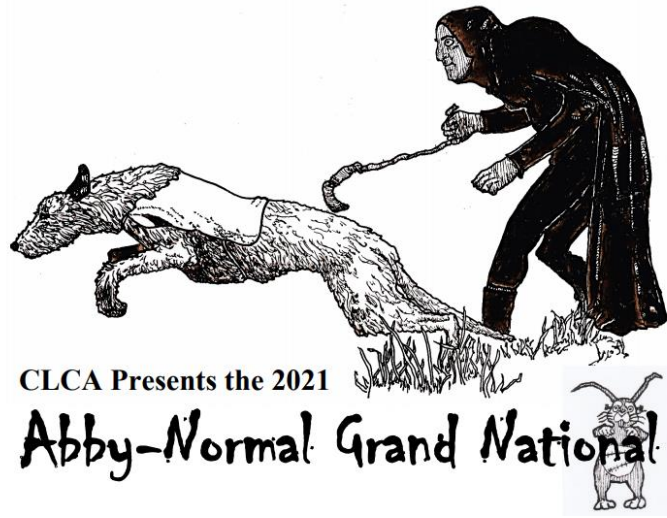

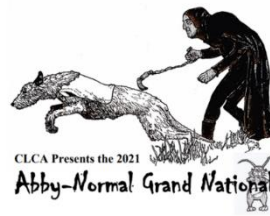

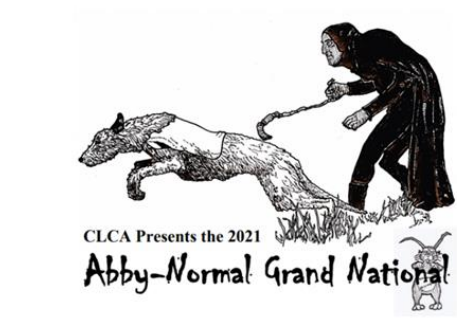

## Animal Advisory Report

# The Healthy Dog Importation Act

In the last issue of the Communique, I reported that the CDC has suspended the importation of dogs from countries classified as “High Risk” for rabies. There is current legislation pending to cover this and similar issues.

On September 24<sup>th</sup> the AKC has issued a Legislative Alert in support of a currently pending bill in Congress entitled “The Healthy Dog Importation Act”. This act is intended to address a potential public health crisis caused by unbridled imports of potentially unhealthy dogs. By focusing on the health status of all dogs for import rather than on country of origin, it can also serve as an alternative to inefficient one-size-fits all bans like the current CDC ban.

AKC strongly encourages all dog owners individually, as well as clubs, to contact their member of Congress and Senators and ask them to support the Healthy Dog Importation Act. This is a bipartisan, common-sense measure to address a significant public health threat for both pets and the people who care for them. Key provisions in the Act are:

- Provide authority to the U.S. Secretary of Agriculture to determine which vaccinations and other health information is required for entry of dogs into the U.S. This authority will be carried out by USDA’s Veterinary Services (VS) division.
- Require every dog entering the U.S. to be accompanied by a certificate of veterinary inspection (health certificate), issued by a licensed veterinarian accredited by a competent veterinary authority recognized by the Secretary. The health certificate must certify that the dog has received all required vaccinations and demonstrated negative test results.
- Require submission of health certificates to USDA, which will maintain a centralized, publicly available data base. Required documentation may be submitted electronically. All submitted information will be made available to the secretaries of Health and Human Services (CDC), Commerce, and Homeland Security (CBP) to promote interagency coordination and facilitate verification upon arrival in the U.S. Required documentation may be submitted electronically
- Require permanent identification of all dogs imported.
- Allow the Secretary of Agriculture to set fees for the issuance of importation permits to help offset costs for increased monitoring and oversight.

# Self-Interview with Tom Golcher

8/30/2021



**What Breed of dogs did I go thru to get to the Breeds I have now?** Borzoi is the first breed I have invested in, as an adult. I have had a couple of pets, a collie and GSD, when I had small children and wanted for them to have a companion. But Borzoi is the first breed I have studied, researched, invested in, and committed to.

**Describe the first time I saw one of my dogs course?** Actually, my first performance event with sighthounds was in Germany and it was oval racing. Oval racing is “THE” sport in sighthound sports throughout Europe. You did not even consider coursing until your dog either lost a step or two on the track, or just was not suited for the track. My first coursing event was with my amazing borzoi, Silkenswift Ambassador. He had already broken 6 speed records on European oval tracks, won the World Oval Racing Championship in 1999, and at 6 years old we tried him out at coursing. Wouldn’t you know it the lure went out about 100 yards and turned RIGHT. The oval track was only left turns. Ambassador shot out with his normal blazing speed, turned left and then “where did the lure go”? He leaped about. Saw the lure on the other said of the field and he took pursuit. He was a quick learner. We returned to the US shortly thereafter and his first big event was the CLCA Grand National, which he won as a 7-year-old. Only the 2<sup>nd</sup> borzoi to ever win the GN. Since coursing is the event most available, we dove in with both feet.

**When did I attend my first field Trial?** In the US it was Spring of 2003 at CLCA in Colorado. In Europe in was fall of 2000.

**When did I start working at trials?** I started working German events in 1995. I started working US ASFA events in 2004.

**What positions have I performed in putting on trials?** FTC, FTS, Clerk, Huntmaster, Paddock, Lure Operator, Equipment manager, and judge.

**What positions have I held in ASFA?** Regional Director, ASFA Judge, LRP Committee Chair, FTI Committee Chair and member, PCC Committee chair

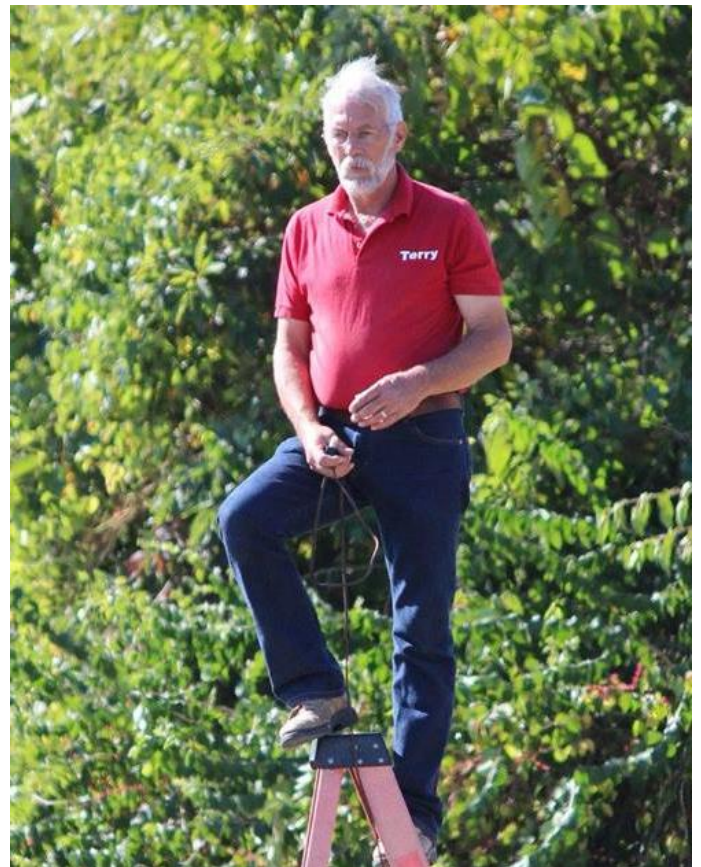
**I feel the biggest challenge facing ASFA today is?** Safe fields, Getting new involvement.

**What are my future plans and where does AFFA Lure Coursing fit in?** My future with ASFA will continue until I can no longer physically or mentally do the job. At 70 one does not know how many years I can contribute on the level at which I do.

KC & I currently hold monthly events on our property, the Zoiboyz Ranch, to help exhibitors get the right start in the running sports. We hold Fun Runs for coursing training and certifications, LGRA, NOTRA and ZASSC (our own competition event), and box training. I train lure operators, Huntmasters, and paddock masters at these events, to help them get the right start and understand the importance of each of these positions. Several very good lure ops have come thru my mentor program over the years.
