LETTER FROM PRESIDENT PHIL FULLAM

It was with some trepidation that I accepted the nomination for President of the ASFA. There have been so many great past leaders of the ASFA over the past 50 years who have shaped and guided the organization and built it into what it is today. I am grateful for all their contributions and vision.

The ASFA has survived a very difficult time during the past decade with declining entries, hard-to-find coursing fields, aging membership, and of course COVID-19. It is a testament to the dedication of our clubs and their members that we have emerged strong and with a bright future.

The last four years have marked significant progress, such as stabilization of our finances, the contract for a workable new records program, and more importantly, an energy level within the Board of Directors that has made it exciting to be a part of the organization.

As incoming President, I want to continue the momentum of the Board of Directors, maintain the schedule of quarterly board meetings, support our committees, and ensure that we implement the new records program quickly. As has been pointed out by many people, we need to address the shrinking entry levels and the risks posed by the aging of our participants.

There is no magic bullet for the decline in entries. The competition for entries, and even for available weekends on which to hold events, has become fierce. In every part of the country, it is basically a given that our field trials will be on the same weekend as some other event, whether it is barn hunt, obedience, agility, or other fun events.

We are also in direct completion with the AKC and their field trials, CAT and Fast CAT events. Those events have saved may clubs from financial doom, generating positive cash flow, which in turn supports our field trials. We need to recognize the synergy



these events offer and build on it. Our own LCI program was developed to offer a better alternative to the AKC events. We need to continue to look at how we can offer better events with higher satisfaction levels for the competitors.

An area that has improved, but still needs significant work, is the rate at which we respond to change. Our current structure of the Constitution and Running Rules reflects a pace from past decades of slow change, of snail mail, and stability in the environment. The structure of our board meetings makes responding to basic problems slow and gives the appearance that the Board is not listening.

For those who do not know, for the board to pass a motion, the motion must first be submitted and receive 3 seconds, which can take up to 3 days, then there is a mandatory 5-day discussion period, followed by a 5-day voting period. Translation... it takes two weeks for the board to take action.



2022 International Invitational Committee Report by Kathy Nelson

The trivia question: What is the original recognized lure coursing club in the whole world?

The answer: The American Sighthound Field Association.

FIFTY years ago, a small group of people recognized just seven Sighthound breeds that began our sport. These seven breeds are still seen on our logo.

Lure coursing is now included in the AKC program and coursing clubs throughout the world. As we celebrate our golden anniversary, 50 years, the ASFA board invites you to the 44th running of the International Invitational and the second running of the LCI specialty. This event will be at the Aeronautical Field in Muncie Indiana. The LCI will be Oct21 and the II will be October 22-23,2022. As our sport has grown and evolved, now all dogs are offered an opportunity to run.

The Co-Chairs are Kathy Nelson, Dawn Gibas, and Greg Breitbach.

Our Field Trial Secretary is Katie Kaltenborn, with the direct assistance from Mary Francis Miller. Once again, they will use the electronic recording program LC-Soft written by Eddie Kominek. This program makes the FTS job much easier than the original paperwork.

Our lead lure operator is Jerry Slattery. We will run 3 fields with Mark Schubert and Scott Hurlbert each in charge of a field. Jerry's lure operating team will also include Dale Parks, Eddie Kominek, Matt Coughlin, Josie Haumont, Tom Golcher, Tom Cigolle, and Joe Shoemaker. Joe will bring equipment from Raisin River and MGA, and Jerry will bring equipment from GANG.

Our judges will be Kevin Carlson, Kent Standerford, Deann Britton, Jennifer Geisler, Claudia Miller, and Ping Pirung

Lead huntmaster is Wayne Olson. Kay Nierengarten is our experienced treasurer. Leah Hartlep will do the catalog. She did a great job last year! Sabrina Hiller-Wright will once again organize and arrange all the trophies. Katie will have the pre-trial paperwork completed when she arrives. We will organize field clerks for recording judges scores. There will be a paddock for each of the three fields. The Aeronautic field complex has PA systems, tents and tables.




Isha

Points Available for Best of Breed

The winner of Best of Breed receives the higher number of points available from the Open, Field Champion or Veteran stake, **but must defeat the winner(s) of the other stake(s) in a run-off**.

Qualifying Placement

- A hound must defeat a qualifying hound to count as a qualifying placement towards title requirements.
- A single entry in a stake, who defeats another hound to win Best of Breed, will earn a qualifying (competitive) first placement for defeating a qualifying hound. A single entry in a breed, awarded Best of Breed, will earn a first placement for winning Best in Field against a qualifying hound.

Best in Field

The hound winning BIF now gets 4 points for each hound that has competed in BIF in addition to the points earned in the regular stake up to a maximum of 40 points total.

IT COMMITTEE Report Cathy Sanderson, Chair

As you may know, ASFA began working with a software company in 2017 to develop an online version of our record keeping software. Despite our best efforts, that software company was unable to deliver a working software system to us. Accordingly, we've moved on.

We are now working with Eddie Kominek, with a development plan that is composed of 4 stages, each taking 6 to 8 months. The first priority is to replace the record keeping system that has been cobbled together for the past decade. The new structure will better handle the LCI program and allow for expansion and changes as needed. Eddie

is using a programing system called Laravel which is a powerful open-source framework based on PHP. I don't want to bore everyone with the geeky tech stuff. If you want to discuss details, please contact Eddie or me. However, rest assured that Eddie is using standard Laravel procedures and practices to ensure that any other Laravel programmer could read and understand the code that he is writing.

The ultimate goal of this project is to have:

- All ASFA's trial records online and accessible by dog owners on a searchable website
- Trial results can be submitted electronically by the FTS
- The ASFA website will be updated by designated committee chairs.
- Make available payment processor so that clubs can take online entries if they wish.
- Mobile friendly
- Searchable rules and policies

So far Eddie has changed the structure of the tables and program structure significantly from the old MS Access system. This is important because it will allow for flexibility and future improvements. There is a lot of testing to do to ensure that the old data behaves as expected when the data is reported. This first stage of work is the hardest and most important since it will provide the framework for the rest of the development. Also, the system is being developed to with work with LCSoft, which is the only computer program that ASFA accepts to do random draws.

RECORDS COMMITTEE Report Kathy Sanders, Chair

A lot of progress has been made regarding the records program since ASFA and Eddie Kominek have entered into a contract for a new records program. Each of the 4 Phases to the plan has clear acceptance points and deliverables, with an anticipated 6 to 8 months to complete. We are excited to see a clear path to completion and



have all the confidence that Eddie Kominek can provide the new records program that ASFA needs. Eddie set out the 4 phases in detail at the ACoD, as follows:

Phase 1 – Records Program & Website Update

- More user friendly design utilizing an established CMS such as loomla
- All the existing static information and pages
- Import & convert the historical data
- Records Coordinator access and data entry
- All the reporting functions that exist now
- Recode results pages (Top 20, Lifetime, Trial Results, Hound Records, etc.) on the website to be dynamically generated
- Administrator access limited to web admins and Records Coordinator
- File management and upload capabilities
- Simple Trial Date Request Form with email notification, to be replaced later

GiGi was an outstanding representative of the breed. Over her coursing career she defeated 584 dogs, won 35 BOBs, and 2 BIFs. She currently sits at #10 on ASFA's Lifetime Top 20. She was ranked as Basenji #6 in 1996, #1 in 1997, # 8 in 1998, and #3 in 1999. She was a multiple Best in Field winner and the second LCM 4 Basenji ever. In 1997 when GiGi was the #1 Basenji, she had the all-time record of 230 Bowen Points. She spent fewer days on the coursing field in 1998 going for Bench Championship majors and agility. Even then she was #3 in 1999 and received her LCM 4. Gigi continued coursing and received her LCM 5. GiGi won the Open Tri Class at the 1997 BCOA National Specialty.

Nitro was always the gentleman, both on and off the field and could be trusted to run with any dog. His signature shredding of bags at the end of a course, or at a broken course, was to the dismay of many a huntmaster. He started his running career in LGRA and began coursing at two years old in 2007. Nitro ran in 387 ASFA trials and in just enough AKC trials to earn his DC and MC titles. At 80 pounds and 25" tall, he had the speed and agility to run with most of the fastest female RRs of his time. Although difficult to get to the line as a youngster, he soon became all business, saving his energy for the field and standing perfectly still at the line until the "Tally Ho!". Nitro remained competitive into his veteran years, ranking in the Top Ten ASFA RRs every year he ran, except for 2016, the year in which he retired in July. He was also in the RRCUS Combined Top Twenty every year he ran except for 2016, with three of those years in the Top Ten. He was also the perfect Certification dog, as nothing could distract him from the bunnies. Nitro is one of only four RRs, and the only male, to attain an LCM7 or higher and the only RR to attain a VLCM4. Nitro earned the RRCUS Versatility Certificate by titling in conformation, coursing, racing, obedience, and with participation in herding and therapy dog work.

Nitro is the #2 ASFA Lifetime RR. He is tied with his kennel mate, Voodoo. Nitro defeated 1063 dogs, and earned 49 BOBs and 1 BIF. He is the highest ranked male RR in ASFA history. In 2007, Nitro was #2 ASFA RR, #1 LGRA RR, #5 RRCUS Combined (ASFA + AKC Bowen Pts). From 2008-2015 he earned the following placements:

2008: #2 ASFA RR, #9 RRCUS Combined 2009: #2 ASFA RR, #11 RRCUS Combined 2010: #1 ASFA RR, #2 RRCUS Combined 2011: #6 ASFA RR, #16 RRCUS Combined 2012: #5 ASFA RR, #14 RRCUS Combined 2013: #7 ASFA RR, #18 RRCUS Combined 2014: #4 ASFA RR, #11 RRCUS Combined 2015: #4 ASFA RR, #17 RRCUS Combined

The very first time Finnegan saw a plastic bag on a coursing field, he was 5 months old. I had seen a flyer for a coursing practice for a club forming locally. The field was set up in a park that was close to the Meramec River. We didn't know any better and let this puppy run the entire course. The interesting part was that the 1993 Midwest Flood was just beginning to flood the field and this puppy ran through the water at the back of the course without an issue. The water was beginning to back up from the overflowing Mississippi River.

Finnegan began his relatively short lure coursing career at Crown Point, Indiana on April 30, 1994 – back in the days before certification runs were required. He was never the fastest Wolfhound on the fields, but I doubt whether there were many that were more determined to catch that plastic bag and shred it. Finnegan competed for four years and was in the breed's Top Twenty every year. What makes Finnegan different is that he was a dog in a breed when the bitches are more successful. Finnegan was been the only Irish Wolfhound dog to ever earn an LCM2 title. His last competitive run was at the 1998 International Invitational in Kentucky as he battled lymphoma. He retired as the #6 Lifetime Irish Wolfhound, but has currently dropped back to #12.

Finnegan was bred by Lynn & Judy Simon (Stoneybrook Kaos x Stoneybrook Mayhem). He was whelped on January 2, 1993. Finnegan ran in his last trial on June 7, 1998.

ASFA was established in California 1972. Nancy Oliver was among the originators, along with Lyle Gillette (the "ASFA creator"), Mike Oliver (Nancy's husband), Tom and Betz Leone, Betty Blalock, Bud Pine, and others. Nancy Oliver became the ASFA Secretary-Treasurer (1972 – 1973), FAN Editor (1972-1973), and Scheduling Coordinator (original 1972-197?). In Sept 72, Nancy Oliver and Barbara Ortman developed a logo (ASFA's second logo) which succeeded the unofficial logo that had appeared on the June 72 rule book. Their logo appeared on all ASFA Rules, the FAN cover, the Field Champion certificates, and was the official logo of ASFA.

Nancy Oliver also became the Corresponding Secretary (1976-1977). She was very instrumental in developing the original trial forms for Field Trial Secretaries to use and Records Coordinator to use.

Nancy Oliver was one of ASFA's first judges.

Nancy Oliver also helped spread "the word" about ASFA beyond California. She traveled and came as far East as Colorado a number of times in the early years to ran her dogs in Colorado's Grand National.

Unfortunately, we do not have a photo of Nancy Oliver or of her ASFA loga. But if anyone out there has any photos, we would be so appreciative if you could please share them with us.

JOE SHOEMAKER

Joe began coursing around 13 years ago with his Whippet "Phoebe". The lure coursing bug got him, and he and his wife Caren added more Whippets to their household and coursed them to many titles. I think they even moved into a new house for the dogs.



Along the way Joe became enamored with the sport of lure coursing and learned all aspects of working at and hosting a field trial. He has held all positions during a field trial from paddock to huntmaster to lure operator to field trial secretary to field trial chairman. He was named Lure Operator of the Year in 2018 by the Lure Coursing Judges Association (LCJA).

When Joe shows up at a field trial, he steps out of his vehicle ready to help. He comes early and stays late even though he has a long drive home on a Sunday. 

Gary Forrester was a man that was always willing to share his knowledge, discuss your ideas as well as help guide newcomers learning the thrill of lure coursing. The Tri-State Sighthound Club feels Joe embodies in his heart Gary's contributions to the sport of lure coursing, dedication and philosophy. Joe Shoemaker is a giver and is more than deserving of the Gary Forrester award that exemplifies all his selfless efforts over the years. — *Ping Pirrung*
