#### **ELIGIBLE BREEDS & REGISTRY**

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds are listed on the ASFA website and must be individually registered with the appropriate registry.


When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

- All entries must be one year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, hounds with breed disqualifications, and lame hounds will be excused.
- Hounds not present at the time of roll call will be scratched.
- Running Rules Chapter I Section 3. Hounds determined to have a breed disqualification at the time of roll call shall be barred from regular competition and be given the option of entering the Singles stake. Should they choose not to enter the Singles stake, their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered in regular competition.
