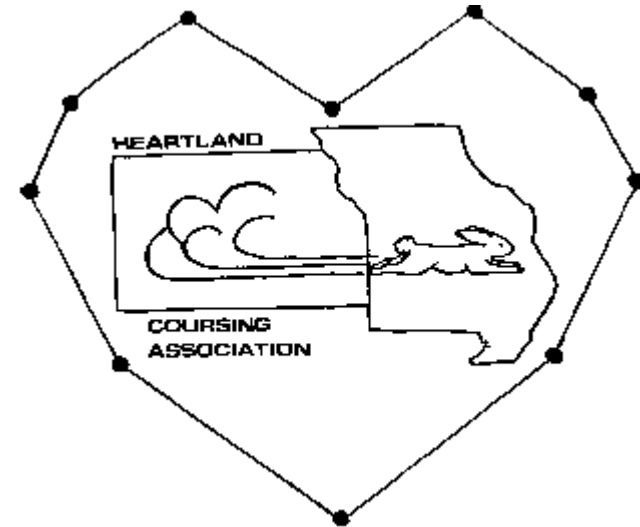

RIBBONS & TROPHIES

Ribbons will be awarded for all placements 1st through NBQ. Rosettes will be awarded for Best of Breed and High Scoring Single. Trophies will be awarded by club donations. 1st Place – Blue, 2nd – Red, 3rd – Yellow, 4th – White, NBQ – Green, High Scoring Single – Navy and Gold, Best of Breed – Purple and Gold, Best in Field – Red, White and Blue. We are pleased to offer each dog that earns a new ASFA title at our trial a New Title rosette. Please notify the FTS if your hound might earn a new title at our trial

SPECIAL TROPHIES AND AWARDS FOR SALUKIS:

In conjunction with HCA's trials on October 29-30, 2022, the ASA (American Saluki Association) will be offering the Brahma II Cup and the South Central Regional trophy for Salukis only. To claim either trophy, the winning Saluki must be owned by an ASA member. Detailed information on the Saluki trophies, eligibility and run-off information is provided at the end of the premium.

ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhounds, Sloughis, and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the provisional stake or the Singles Stake. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Notice for First-Time Entered Hounds

All first time entered hounds MUST include either the completed judge-signed ASFA certification or waiver certificate or AKC Qualified Courser certification **and** a copy of the hound's registration to the FTS **before** entries close to be considered complete. First time single entrants do not need a hound certification/waiver. Registration is not required for NGA Greyhounds. If the paperwork is not present it will be considered a conditional entry. Conditional Entries are not accepted.

REGULAR STAKES OFFERED

Open Stake: Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

Field Champion Stake: Any ASFA Field Champion.

Veteran Stake: Any eligible sighthound that has met certification requirements whose age is at least six years or older. (5 years for Irish Wolfhounds, 7 years or older for Afghans, Ibizans, Rhodesian Ridgebacks, Salukis and Whippets. Points go toward V-Fch or V-LCM titles.

Single Stake: Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP (Title of Coursing Proficiency) and CPX (Coursing Proficiency Excellent) titles from the Singles stake. Provisional breeds are not eligible for these titles.

Provisional Stake: Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible to compete for Best of Breed or Best in Field. Points and placements are awarded, but not title certificates until the breed is fully recognized by ASFA.

Lure Coursing Instinct (LCI Stakes)

Open to non-sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP, CP, PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registry fee at time of entry. Entries will be limited to 15 hounds.

- **Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.
- **Small Senior:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.
- **Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.
- **Small** will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.
- **Large Open:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.
- **Large Senior:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.
- **Large Veteran:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.
- **Sighthound Mix Open:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.
- **Sighthound Mix Senior:** for dogs with sighthound breed in its background who have achieved the title of LCC.

- **Sighthound Mix Veteran:** for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial.

CONDITIONS OF ENTRY (Applies to all stakes):

- ✓ All entries must be one year of age or older on the day of the trial.
- ✓ Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more after inspection. All hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified.
- ✓ Each hound will be inspected for lameness, breed disqualifications, and bitches in season.
- ✓ Bitches in season, hounds with breed disqualifications and hounds lame at roll call will be excused and entry fees refunded.
- ✓ No other refunds will be given.
- ✓ Monorchid, cryptorchid, spayed and neutered hounds without breed disqualifications may be entered.
- ✓ Hounds with breed disqualifications are only eligible to enter the Single Stake.
- ✓ Hounds not present at time of roll call will be scratched.
- ✓ Muzzles are not required, but it is the responsibility of the owner to determine if the hound should be muzzled.
- ✓ Dogs may not be tied or staked out. There will be a \$5 penalty fee for any hound loose on the field, other than those running the course in progress.
- ✓ There will be a \$25.00 fee for returned checks.
- ✓ Lure coursing blankets may be provided by the club.
- ✓ Incomplete, unsigned, conditional, or late entries WILL NOT be accepted.
- ✓ Entries will not be acknowledged by mail or email.

EQUIPMENT AND COURSE PLANS

- HCA reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. In this event, a new course plan will be posted
- The course will be reversed for finals and again for run-offs or at the discretion of the judges.
- The lure machine is a battery powered, continuous loop machine. Backup equipment will be available.
- The lure will be white plastic bags.
- The field consists of gently rolling terrain.
- The total course length for Saturday is 715 yards – Sunday is 640 yards.

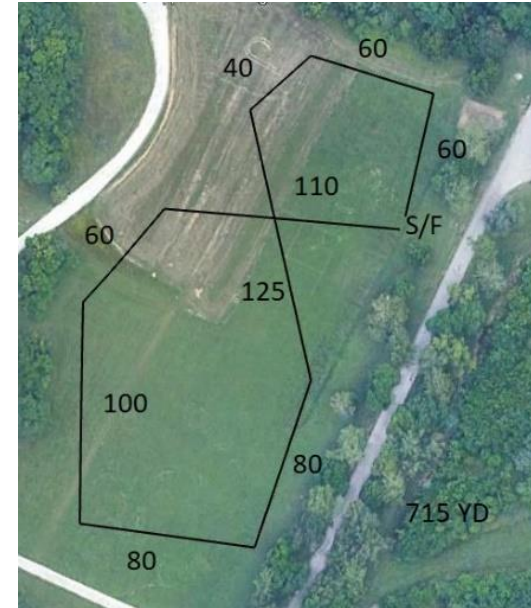
SITE INFORMATION

- Everyone must clean up after his or her dog.

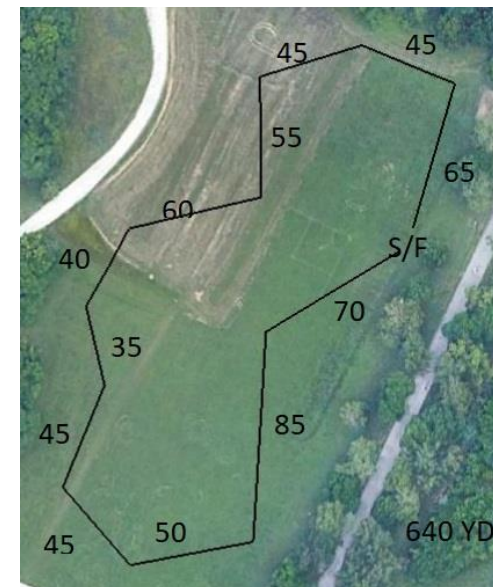

Saturday – Yards – 715 Yards



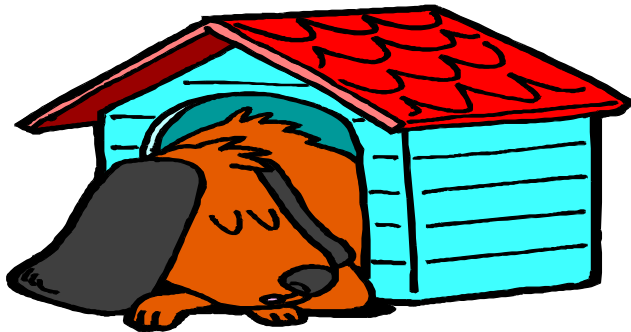
Sunday – Yards – 640 Yards

- Will be offered on Saturday after ribbons--time, weather and equipment permitting.
- For certification runs:
 - You'll need to provide a completed Certification form to the judge prior to the run. Bring two copies if you want one copy for your records and one copy to submit with your first entry.
 - Owner of the hound to be certified is responsible for arranging for a certified hound with which to certify.
 - Hound Certification runs and practices are \$5.00 for non-club members. No fee for club members.
 - Sign-up sheets will be available at the FTS Table after the first run goes to the line for Prelims.

ABOUT THE AMERICAN SALUKI ASSOCIATION (ASA) BRAHMA II LURE COURSING CUP

The oldest lure coursing trophy offered by the ASA, the Brahma II Cup is a sterling silver elliptical bowl with silver ornamentation, and rests on a wooden base with plates for the names of the winners. First presented in 1973 by the Hounds of Srinagar, it honors Am Can Ch Srinagar Brahma of Urray, FCh, bred by Richard and Barbara Webster (Urray) of British Columbia. Not only was Brahma II accomplished on the lure, but his brother Bedouin was the first recipient of this coveted award. The earlier Brahma II Cup trials were always run at Santa Barbara, but currently it is a roving trial held in the various regions of the ASA, awarded annually.

Eligibility requirements to receive the Brahma II Lure Coursing Cup award:

To be eligible to win the Brahma II Cup (or compete in any ASA lure coursing cup run-off), at least one owner of the qualifying Saluki must be a member in good standing of the ASA before roll call is called before the draw on the day of the trial. Under no circumstances can a Saluki who is owned by a non-ASA member compete in a cup run-off. Salukis entered in the Singles stake are not eligible, only Salukis entered in the Open, Field Champion or Veteran stakes qualify to compete for the trophy.

Brahma II Cup Run-off Rules:

In the event there is only one eligible stake - The first place Saluki in that stake wins the cup.

If the first place Saluki in that stake is owned by a non-ASA member, the award is presented to the highest-scoring ASA member-owned Saluki in that stake.

In the event there are two or more eligible stakes, if the BOB winner is ASA member-owned, that Saluki wins the cup.

If the BOB winner is NOT owned by an ASA member, it does not win the cup. A special run-off of the top scoring ASA member-owned Salukis from each eligible stake will determine the cup winner. Highest scoring Saluki in this special run-off wins the cup.

If there is no time for a special cup run-off, the award will be shared by the highest scoring ASA member-owned Salukis from the eligible stakes.

ABOUT AMERICAN SALUKI ASSOCIATION (ASA) REGIONAL LURE COURSING TROPHIES:

The ASA Regional Lure Coursing Trophy is a perpetual trophy offered to the winner of a special run-off between the highest scoring or BOB ASA member-owned Salukis over a two-day ASFA lure coursing trial event. The regional lure coursing trophies were commissioned by donations from the various ASA regions and created by Saluki breeder, conformation, and lure coursing judge, and noted sculptor Garry Newton. The trophies can be awarded annually and must be awarded on the second day of a two-day ASFA field trial event put on by any ASFA club. The Saluki that wins any ASA Regional Lure Coursing Trophy must be owned by an ASA member.

ASA Regional Trophy (awarded second day of two-day event)

Eligibility requirements to receive award:

To be eligible to win an ASA Regional lure coursing trophy (or compete in any ASA lure coursing cup run-off), the owner of the qualifying Saluki must be a member in good standing of the ASA before roll call is called before the draw on the first day of the trials. Under no circumstances can a Saluki who is owned by a non-ASA member compete in a trophy run-off. Eligible Salukis must be entered and run two qualifying courses each day of the two-day ASFA event. Salukis entered in the Singles stake are not eligible, only Salukis entered in the Open, Field Champion or Veteran stakes qualify to compete for the award.

Run-off rules:

This perpetual trophy is awarded to the winner of a special run-off between the highest scoring or BOB Salukis in the eligible stakes over a two-day lure coursing ASFA trial event, as follows.

The BOB Saluki on the first day that is registered to at least one ASA member as of roll call on the first day will run off against the BOB Saluki on the second day that is registered to at least one ASA member as of roll call on the FIRST day. If the same Saluki so registered is the BOB Saluki on both days, that Saluki is declared the winner and no run-off will be necessary.

If the BOB Saluki on one day is not owned by an ASA member but the BOB Saluki on the other day is owned by an ASA member, or if no BOB winner is owned by an ASA member, the highest scoring ASA owned Saluki from the eligible stakes (or flight if stakes are divided) each day is eligible to run for the trophy.

If there is no time for a run-off at the end of the second day, the BOB or highest scoring ASA member owned Salukis from each day will share the award.
