### From the north / Santa Fe:

Take I-25 Exit 290 and head south on US-285 for ~6.5 miles. Turn right onto Highway 41 and follow it for 44 miles to McIntosh. Turn right onto Clements Rd. The field is 1 mile down, on your left.

### From the east or west via I-40:

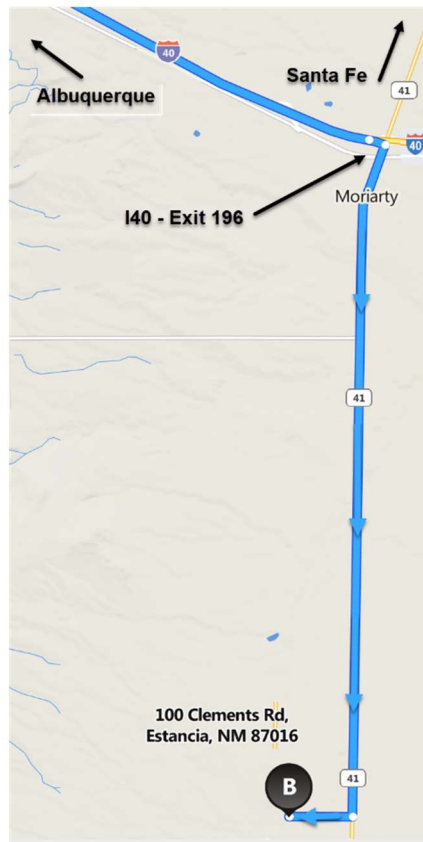
Take I-40 Moriarty Exit 196 (Highway 41) and drive south 9.5 miles to Clements Road. Turn right, the field is 1 mile down on your left.

### From the south / Socorro:

Take I-25 Exit 175 (Highway 60). Follow Highway 60 for 51 miles east. Turn left / north on Highway 41. In 19 miles, turn left onto Clements Road. The field is 1 mile down on your left.

**Elevation is 6,142'.**

## ELIGIBLE BREEDS & REGISTRY

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Silken Windhounds and Whippets may be entered in the regular stakes.

Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds are listed on the ASFA website and must be individually registered with the appropriate registry.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association (NGA), including the United Kennel Club (UKC), the Federation Cynologique Internationale (FCI), an ASFA-recognized foreign or ASFA Board approved registry or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Provisional stake entries shall be individually registered with the appropriate registry. (Dogs with an Indefinite Listing Privilege (ILP) or Purebred Alternate Listing (PAL) from the American Kennel Club shall be considered registered with that body.)

## REGULAR STAKES OFFERED

**OPEN STAKE:** Any eligible sighthound, excluding ASFA Field Champions of record that has met the certification requirements.

**FIELD CHAMPION STAKE:** Any ASFA Field Champion

**VETERAN STAKE:** any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Afghan Hounds, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. That has obtained an ASFA certification, AKC QC, or other qualifying waivers prior to the closing date. A copy of the certificate MUST be submitted with the entry forms. Points go toward V-FCh or V-LCM titles.

**PROVISIONAL STAKE:** Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

**SINGLES STAKE:** Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake.

## BEST IN FIELD WILL BE OFFERED BOTH DAYS

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. • Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

## LCI STAKES OFFERED

**LURE CHASING INSTINCT (LCI) Stake:** Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**SMALL OPEN:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**SMALL EXCELLENT:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**SMALL VETERAN:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**LARGE OPEN:** for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**LARGE EXCELLENT:** is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**LARGE VETERAN:** for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**SIGHTHOUND MIX OPEN:** for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**SIGHTHOUND MIX EXCELLENT:** for dogs with sighthound breed in its background who have achieved the title of LCC.

**SIGHTHOUND MIX VETERAN:** for dogs with sighthound breed in its background over the age of 7 years.

When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

LCI Entries: Check **TWO** boxes on the LCI entry form, one for Small / Large / Sighthound Mix and one for Open / Excellent / Veteran.

The

**Beth Anne Gordon Memorial Trophy** is won by the highest scoring sighthound in the regular stakes (Open, Field Champion, and Veterans) over the weekend. For 2025, scores from **Phil Fullum** and **Robert Place** will be used, as both judge all breeds over the two days. If your breed is judged twice by Phil, then Saturday scores will be used for Afghan – Irish Wolfhounds, and Sunday scores for Italian Greyhounds – Whippets and Provisional Breeds.

### **Certs, Practices, and Fun Runs**

Up to five certification runs are available before the trial each day. If you wish to reserve one of these spots, send in an early entry for your dog in the **SINGLES** stake along with an additional \$10 and a request for a certification run. Owners are responsible for supplying a dog of similar running style. Dogs who pass the Certification run can be moved to the appropriate Open or Veterans Stake after re-inspection.

**Additional Certification runs (\$10) and Practices and Fun Runs (\$5)** will be available on Saturday after the trial, so long as equipment, weather, and daylight allow. A sign-up sheet will be posted on a table next to the Equipment Trailer.
