- SIGHTHOUND MIX SENIOR STAKE: For dogs with sighthound breed in its background that have achieved the title of LCC.
- SIGHTHOUND MIX VETERAN STAKE: For dogs with sighthound breed in its background that are over the age of 7 years.




### **Conditions of Entry**

All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call.
