

#### ELIGIBLE BREEDS AND REGISTRIES

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, and Whippets may be entered in the regular stakes. Provisional breeds may be entered in the Provisional Stake or the Singles Stake. Provisional breeds currently include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

#### ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL OR E-MAIL

Late, incomplete, unsigned, unpaid, or conditional entries will not be accepted. Substitutions may be made for hounds lame or in season prior to roll call. Storz Rugby Field, NCA nor its members will be responsible for any accidents at this trial. A Field Secretary shall refuse any entry for the **Open**, **Veteran**, or **Provisional** stake marked —First Time Entered if a Hound Certification does not accompany the entry unless the hound has a title, which waives this requirement. Remember to include a copy of the hound's registration with —First Time Entered hound. A copy of registration is not required for NGA hounds.

ELIGIBILITY FOR REGIONAL INVITATIONAL: Any hound that has at <u>least one ASFA point</u>, is <u>pointed in its country of residence</u>, or is <u>AKC pointed</u> is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned prior to the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals. Hounds entered in the Single Stake are not eligible to be entered in Breeder, Kennel, or Bench stakes.

#### STAKES OFFERED

<u>Open</u>: Any eligible sighthound that has ATLEAST ONE POINT, excluding ASFA Field Champions of record. <u>Field Champion</u>: Any **ASFA** Field Champion.

<u>Veteran</u>: Any eligible sighthound that has AT LEAST ONE POINT and that is 6 years of age or older (5 years for Irish Wolfhounds; 7 years or older for Afghans, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets)

<u>Singles</u>: Any eligible sighthound, including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

<u>Provisional</u>: Any eligible sighthound of a Provisional breed that has received a placement with competition. Not eligible for Best of Breed (BOB) or Best In Field (BIF).

LURE CHASING INSTINCT (LCI) STAKE CLASSES: Open to NON- sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

<u>Small Open</u>: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

<u>Small Excellent</u>: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

<u>Small Veteran</u>: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 vears

<u>Large Open</u>: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

<u>Large Excellent</u>: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

<u>Sighthound Mix Open</u>: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

<u>Sighthound Mix Excellent</u>: for dogs with sighthound breed in its background who have achieved the title of LCC.

<u>Sighthound Mix Veteran</u>: for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

BEST IN FIELD—will be offered both days.

#### NON-REGULAR STAKES OFFERED ON SATURDAY ONLY

<u>KENNEL STAKE</u>: For hounds of any individual breeds; an entry shall consist of two hounds, designated at time of entry, in one of the regular stakes being owned and kenneled by the same person. Hounds entered in the Singles or LCI Stakes are not eligible.

<u>BREEDER STAKE</u>: For any breed which shall have, designated at time of entry, two hounds bred by the same individual. Hounds entered in the Singles or LCI Stakes are not eligible.

<u>BENCH STAKE</u>: For any eligible sighthound with proof on file with the ASFA of a conformation champion title from the AKC, CKC or both, or a conformation grand champion title from the UKC. Hounds entered in the Singles or LCI Stakes are not eligible.

#### SPECIAL AWARDS OFFERED ON SATURDAY ONLY

<u>LCI BEST IN VARIETY</u>: There will be <u>three</u> Best of Variety awards, one for each LCI Variety (Large Small, and Sighthound Mix). The highest <u>qualifying</u> combined score in each of the three stakes wins. If there is a tie, it will be broken using the highest score from prelims. If a tie remails, it will be broken using the highest score from finals. If that does not break the tie, a coin toss will determine the winner.

### Conditions of Entry:

- ✓ All entries must be one year of age or older on the day of the trial.
- ✓ Stakes will be split into flights if the entry in any one stake is 20 or more hounds at the time of the draw.

  All hounds will run twice, in trips if possible, or braces unless excused, dismissed, or disauglified.

#### REGISTRY

All dogs entered must have a registration number via one of the following:

- A. AKC Registration as one of the recognized breeds.
- B. AKC Canine Partners, which is for mixed-breed dogs and dogs ineligible for AKC registration.

  - The owner has to complete an ASFA Request for unique entry number (last page) and pay a \$10 registration fee (in addition to the entry fee).
  - 2. The Trial Secretary will submit a copy of the form with the records.
  - The owner will retain a copy as proof of request and payment until ASFA provides a permanent number.
  - 4. When received, the new permanent number will be used as the dog's registration number on all future ASFA LCI entries for the dog.

#### STAKE CLASSES OFFERED

A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open:** for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran:** for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

Large Open: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

Large Excellent: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

Large Veteran: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

Sighthound Mix Open: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

Sighthound Mix Excellent: for dogs with sighthound breed in its background who have achieved the title of LCC.

Sighthound Mix Veteran: for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.


