#### CONDITIONS OF ENTRY

- Only pure bred Scottish Deerhounds one year of age or older on the day of the test/trial.
- Bitches in season and lame dogs will be excused. Entries will be refunded. NO BITCHES IN SEASON ON THE FIELD!
- Hounds lame at roll call will be excused with no refund given. However if you have another hound that can be substituted that will be allowed.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are eligible to enter the Single Stake ONLY.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.



- Any eligible Scottish Deerhound that has met certification requirements and is 6 years of age or older.
- Single:
- Any eligible Scottish Deerhound including those disqualified to run in other stakes, and those with breed disqualifications. NOT ELIGIBLE TO RUN FOR BEST OF BRED.
- Kennel:
- Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and owned by the same individual.
- Breeder:
- Any two eligible Scottish Deerhounds designated at the time of entry in one of the regular stakes and bred by the same individual.

#### **ELIGIBILITY & ADDITIONAL INFORMATION**

- Only pure bred Scottish Deerhounds one year of age or older on the day of the test/trial.
- ALL entries shall be individually registered with the AKC (ILP/PAL included), the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry.
- Single stake can have breed disqualifications.
- Dogs not present at the ending time of roll call will be scratched and no refund will be given.
- Entries will be acknowledged by email IF you include a legible email address on your entry form.
- Bitches in season and lame dogs will be excused. Entries will be refunded. NO BITCHES IN SEASON ON THE FIELD!
- A list of all award donors will be printed in the catalog.
- Spayed and neutered dogs are eligible to participate. Monorchid and cryptorchid hounds are ineligible.
- > There will be a minimum \$25 returned check charge.
- ➤ A \$5.00 fine will be assessed for any loose dog on the field that is not competing in the course in progress. A \$5.00 fine will be assessed for any handler not cleaning up after their dog.
