### **Eligible Sighthound Breeds & Registry**

Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### **Sighthound Stakes Offered**

**OPEN**- Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**FIELD CHAMPION** - Any ASFA Field Champion.

**VETERAN** - Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Ibizans, Afghans, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V- LCM titles.

**PROVISIONAL** - Any eligible sighthound of a provisional breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

**SINGLES** - Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

### **Lure Chasing Instinct (LCI) Stakes**

**LCI is offered on Saturday & Sunday, limit of 10 entries per day.**

Open to NON sighthounds and sighthound mixes. All entries shall be individually registered with the AKC (including ILP & PAL) or the UKC. A photocopy of an acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry.

**Small Open**: for dogs 17-1/2 inches or less at the withers and / or brachycephalic ("flat-faced") dogs who have not achieved the title of LCC.

**Small Excellent**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs who have achieved the title of LCC.

**Small Veteran**: for dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs over the age of 7 years.

**Large Open**: for dogs over 17-1/2 inches at the withers who have not achieved the title of LCC.

**Large Excellent**: is for dogs over 17-1/2 inches at the withers who have achieved the title of LCC.

**Large Veteran**: for dogs over 17-1/2 inches at the withers who are over the age of 7 years.

**Sighthound Mix Open**: for dogs with a sighthound breed in its background who have not achieved the title of LCC.

**Sighthound Mix Excellent**: for dogs with sighthound breed in its background who have achieved the title of LCC.

**Sighthound Mix Veteran**: for dogs with sighthound breed in its background over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

### **Other Information**

- All entries must be one year of age or over on the day of the trial.
- Hounds not present at roll call will be scratched. •Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. •Hounds with breed disqualifications are not eligible to enter except in the Single Stake. •Monorchid, cryptorchid, spayed, or neutered hounds may be entered.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Stake will be split if the entry in any one stake is 20 or more hounds at the time of the draw. •Muzzles are not required; it is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. •Back-up equipment is available. •Lure will consist of highly visible plastic strips. •Course will be reversed for finals and again for run-offs
- A fee of \$40 will be assessed for any returned checks. •There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress. •There will be a \$15 fine for any owner/handler who does not clean up after their hound.

### **Reminders:**

**EARLY ENTRIES** must be received at the field secretary's address by **8pm on Wednesday, October 15, 2025.**

**GATE ENTRIES** must be received by the Field Secretary before 7:30am CST. Entries will be acknowledged by email provided an email address is provided. Incomplete, unsigned, conditional or LATE ENTRIES WILL NOT be accepted. Entry forms by minor owner/handlers (under the age of eighteen years) must be signed/co-signed by a parent or guardian. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner, and the Field Secretary is notified at least one hour prior to roll call.

Any entry marked "**First Time Entry**" must be accompanied by a completed ASFA hound certification form or an AKC QC certificate (not required for entries in the Singles Stake). A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry (not required for first time entered NGA hounds).

### **Event Parking**

Parking will be along two sides of the field, NO shade.

Water will be available at a distance, so be prepared and bring your own shade and water for your hounds.

### **Site Information**

The field is fenced. No running water available, there is a pond for cooling off dogs, there is no shade. Bring your own water and shade for your hounds. Porta-John on site.

Keep dogs on lead even before/after trial as there are goats, cows and dogs in fenced paddocks on the property. Please be respectful of the animals and do not let your dogs antagonize them. Note: the animals ARE at a distance from the coursing field and will not be a distraction for dogs coursing.

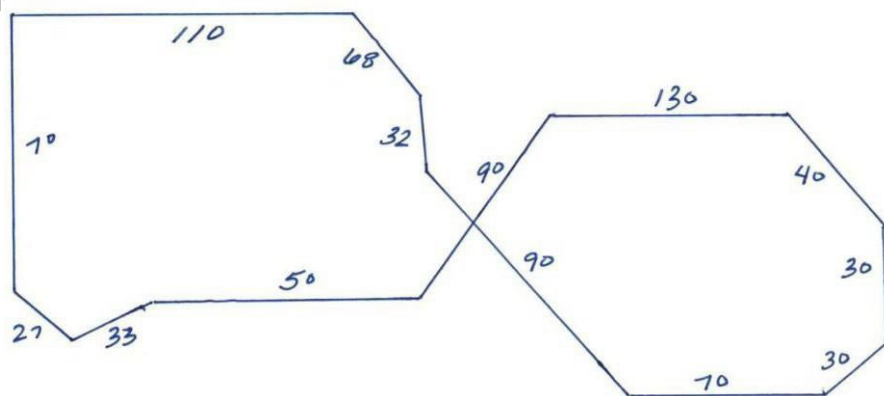
### **Food**

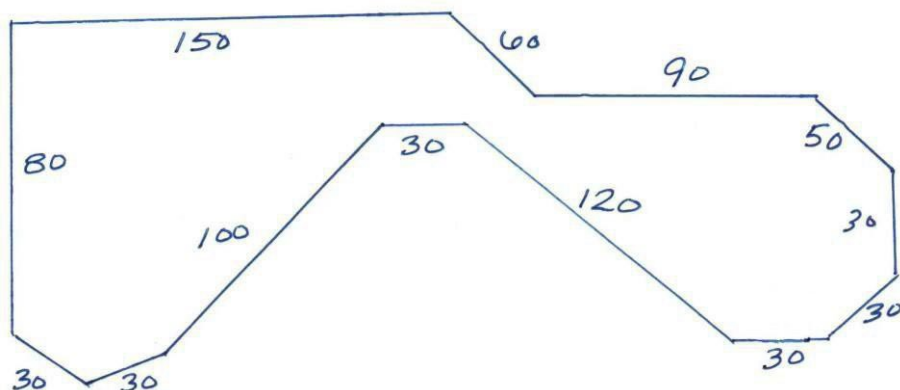
## Saturday 870 YARDS

There will be a \$5.00 fine assessed for any loose hound not participating in the course.

## **Hound Certification Runs and Practice**

**Certification:** Any entry marked *First Time Entered*, other than those entered in the Singles Stake, must present a completed ASFA hound certification form or an AKC QC certificate to the Field Trial Secretary **BEFORE** entries close. See the back of the entry form for certification forms and make extra copies if necessary. A photocopy of an acceptable registry must be submitted with a hound's first ASFA field trial entry. This requirement is waived for hounds registered with the National Greyhound Association.

Certification runs will be offered at the cost of \$5.00 per run on Saturday only after the completion of the Saturday trial. It is the responsibility of the entrant to find another hound of the same breed or similar running style to run with his/her hound for the certification. A sign-up sheet will be available on the day of the trial.

Current SLASH members may certify their hounds at no cost.

**Practice:** Practice will be scheduled after the certifications, time, equipment, and weather permitting.

Practice runs are \$5.00 for non-members. Free for members.
