### Eligible Breeds & Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry. All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

Lure Chasing Instinct (LCI) Stakes Limited to 10 dogs Eligibility: Any dog that has at least one ASFA point is eligible to enter the LCI Regional Invitational. Open to non-sighthound and sighthound mixes. All entries must be individually registered with the AKC (including ILP and PAL) or the UKC. A photocopy of acceptable registry must be submitted with each dog's first ASFA field trial entry. Dogs without a recognized registry number may obtain an ASFA ID number for a \$10 registration fee at time of entry. SMALL OPEN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic ("flat-faced") dogs that have not achieved the title of LCC. SMALL EXCELLENT STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that have achieved the title of LCC. SMALL VETERAN STAKE: For dogs 17-1/2 inches or less at the withers and/or brachycephalic dogs that are over the age of 7 years. LARGE OPEN STAKE: For dogs over 17-1/2 inches at the withers that have not achieved the title of LCC. LARGE EXCELLENT STAKE: For dogs over 17-1/2 inches at the withers that have achieved the title of LCC. LARGE VETERAN STAKE: For dogs over 17-1/2 inches at the withers that are over the age of 7 years. SIGHTHOUND MIX OPEN STAKE: For dogs with sighthound breed in its background that have not achieved the title of LCC. SIGHTHOUND MIX EXCELLENT STAKE: For dogs with sighthound breed in its background that have achieved the title of LCC. SIGHTHOUND MIX VETERAN STAKE: For dogs with sighthound breed in its background that are over the age of 7 years. When running as a stake within a regular ASFA trial, Small will run 50% of the ASFA course as laid out for the sighthounds up to a maximum of 400 yards. All other stakes will run the full ASFA laid out course length.

**Conditions of Entry:** All entries must be one year or older on the day of the trial Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with

breed disqualifications are not eligible to enter except in the Singles Stake • Hounds not present at the time of roll call will be scratched. All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.

**Regional Invitational Requirements:** Any hound that has at least one ASFA point, is pointed in its country of residence, or is AKC pointed is eligible to enter a Regional Invitational in an appropriate stake, including Single Stake, if offered. Proof of non-ASFA points for hounds should be in the form of a photocopy of the certificate, or a page of formal printing, included with the entry. For a Provisional breed to be eligible, the hound must have received a placement with competition. All points or placements must be earned prior to the closing date of the event. An eligible hound may be entered in any number of Regional Invitationals.

### Best in Regional will be offered

### Region 6 Invitational Perpetual Trophies

All perpetual trophies must be returned to the 2026 Region 6 Invitational.

**Irish Wolfhound** — The Brynmair Trophy The Brynmair Trophy, donated by the hounds of Brynmair, is in honor of the coursing Irish Wolfhounds past and present and to encourage the continued participation of those hounds who love the sport of lure coursing.

**Rhodesian Ridgeback** — The Old Goat Trophy Donated in loving memory of Eve, Ch Windriver's Crimson Arrow CD LCM CGC ROM VC. The foundation of Rare Earth Ridgebacks. Eve's claim to fame is more for her descendants than from her own coursing career, which didn't start until she was six years old. Eve earned her LCM at the age of ten and was still used as test dog at fourteen. Eve's descendants include five #1 RRs: Phoebe, Maggie Mae, Ida, Wanda and Nitro, as well as seven Lifetime Top Twenty RRs: Ida, Star, Zappa, Troi, Tango, Wanda and Nitro. Eve's love for coursing was distinguished by her signature chortle before the Tally-Ho and her passion to shred the bunnies...two traits that seem to be inherited by her offspring!

**Saluki** — The Saluki Trophy Donated by Tom Cigolle Jr in loving memory of BIT Montebello Sherom's Fuhais LCM6. Fuhais' wish was to make sure that the Salukis of today and tomorrow are always honored and remembered. Her passion for the chase is the legacy she leaves to us all.

**Whippet** — The Bevis Trophy The Bevis Trophy was originally called The S.L.O. Trophy to commemorate the relationship between Sharon Louise Othick and Bill Othick's Whippet "Spy". The trophy was later renamed to honor "Air Bevis", as he was known in the Othick household. FC TnT's My Foolish Heart, LCM7, LCX was ASFA's highest scoring whippet in 1998, was #4 in 1999 and #11 in 2000. Bevis had enthusiasm and flash on the field and always gave 110%, but was also a great hound at home and returned the love he received ten-fold.

**Best in Regional** — The Director's Cup Donated by Mike Scanlan to honor the Best In Regional Invitational winner, past, present, and future.

### **Rosettes and Medallions**

Rosettes will be offered by ASFA for all placements, 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), High Scoring Single (navy/gold), Best of Breed (purple/gold), & Best in Regional (red/white/blue). Medallions will be offered by ASFA for Best of Breed. Rosettes (pink/green) will be offered by ASFA for the winners of the non-regular stakes. Prizes will be offered by SLASH for all stake winners, best of breed winners, and best in regional. Stake winners will receive a custom lead, best of breed winners and best in regional will receive custom buckets from Aeolus Creations.

### **Stakes Offered**

**Open** Any eligible sighthound that has met certification requirements, excluding ASFA Field Champions of record.

**Field Champion** Any ASFA Field Champion.

**Veteran** Any eligible sighthound that has met certification requirements whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years and Afghans, Ibizan Hounds, Rhodesian Ridgebacks, Salukis, and Whippets, whose age shall be at least seven years. Points go toward V-FCh or V-LCM titles.

**Provisional** Any eligible sighthound of a Provisional stake breed that has met certification requirements. Not eligible for Best of Breed or Best in Field.

**Singles** Any eligible sighthound including those disqualified to run in other stakes. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

**KENNEL STAKE:** For any individual breed, two hounds designated at time of entry that are owned and kenneled by the same person. If in singles stakes, both hounds must be in singles.

**BREEDER STAKE:** For any individual breed, two hounds designated at time of entry that are bred by the same individual. If in singles stakes, both hounds must be in singles.

**BENCH STAKE:** For any individual breed, an individual hound with proof on file with ASFA of a conformation champion title from the AKC, CKC, or both, or a conformation grand champion title from the UKC. Single Stake entries are eligible.

- **EARLY ENTRIES must be received at the field secretary's address by Wednesday, December 24, 2025.**
- **Gate entries must be received by the Field Secretary before 8:00 am CST.**
- Entries will be acknowledged by email provided an email address is provided. Incomplete, unsigned, conditional or LATE ENTRIES WILL NOT be accepted. Entry forms by minor owner/handlers (under the age of eighteen years) must be signed/co-signed by a parent or guardian. Substitutes for lame or in-season hounds are allowed if the substitute has the same owner and the Field Secretary is notified at least one hour prior to roll call.

### **Important Information**

- Muzzles are not required, it is the responsibility of the owner to determine if their hound needs to be muzzled.
- Lure machine is battery powered, continuous loop. Back-up equipment is available.
- Lure will consist of highly visible plastic strips.
- A fee of \$20 will be assessed for any returned checks.
- There will be a \$5 fine for any loose hounds on the field that is not part of the course in progress.
- There will be a \$15 fine for any owner/handler who does not clean up after their hound.
- Course will be reversed for finals and again for run-offs and Best of Breed.
- Hound certification runs will be offered Saturday only following the trial pending condition of the equipment and weather.
- Persons exhibiting conduct detrimental to ASFA/SLASH/any hound(s) /other person(s) will be asked to leave the trial site.

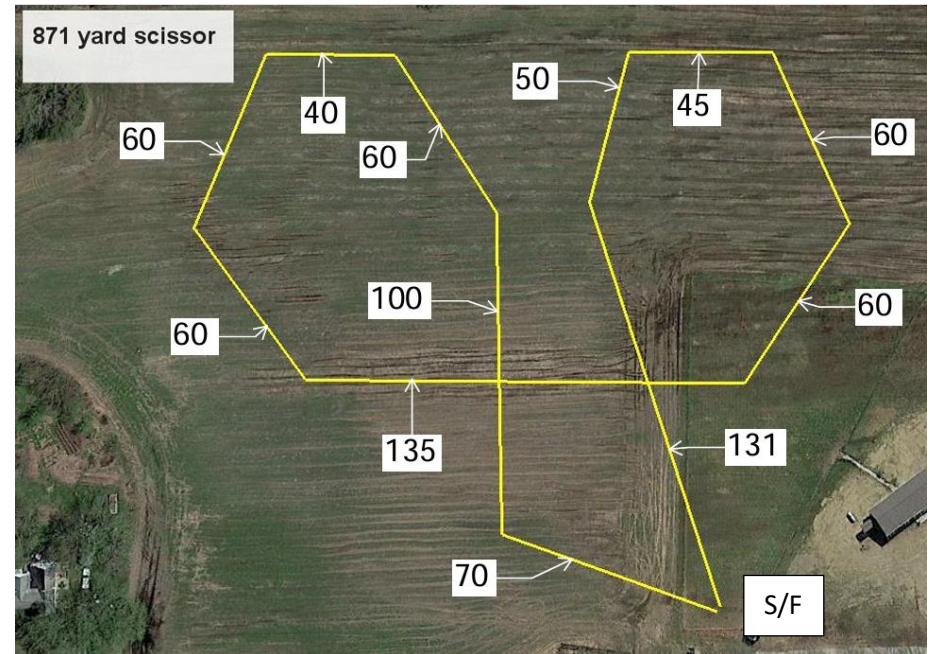
#### • **PARKING:**

- **From 1-55 North or South:** take Exit 37 for Livingston/New Douglas, go East approximately 5 miles into the town of New Douglas, turn left (North) onto Main Street (at the stop sign), then in 1/4 mile turn right (East) onto Sorento Road. Go approximately 5 miles and turn left onto Griffiths Road. Field is 3/4 mile on the right, just past the county rock pile (which is on the left).
- **From 1-70 East or West:** take Exit 36 for Pocahontas and go North approximately 4 miles to IL-140 (first stop sign). Turn left (West) on IL-140, go 1 mile then turn right (North) onto Old Ripley Road. Follow Old Ripley Road 6.3 miles to stop sign, turn left (West) onto New Douglas Avenue. Go 0.4 miles, turn right (North) onto Griffiths Road. Field is 3/4 mile on the right, just past the county rock pile (which is on the left).
