### Ribbons

Ribbons or rosettes will be offered for all placements: 1st (blue), 2nd (red), 3rd (yellow), 4th (white), NBQ (green), High Scoring Single (navy/gold), Best of Breed (purple/gold). Other prizes may be offered by MGA and friends of MGA.

**Trial Hours:** 7:00 A.M. until one hour after the last scored course of the day

Substitutions will be accepted for lame or in-season hounds.

Make checks payable to "MGA" in US funds. Do NOT send entries "signature required". Entries will NOT be acknowledged by mail. Late, incomplete, or unpaid entries will not be accepted. Entries will be acknowledged by e mail if a legible e-mail address is provided on the entry form. There will be a \$25 fee for any returned check.

### Conditions of Entry

- All entries must be one year or older on the day of the trial
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more
- Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake
- Hounds not present at the time of roll call will be scratched
- All hounds will run twice, in trios if possible or braces (except in the Single Stake and all LCI Stakes), unless excused, dismissed or disqualified.

### Eligible Breeds & Registry

Only purebred Silken Windhounds and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (ILP/PAL included), the NGA, the UKC, the FCI, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA.

### Regular Stakes Offered

**OPEN STAKE:** Any eligible Silken Windhound, excluding ASFA Field Champions of record that has met the certification requirements.

**FIELD CHAMPION STAKE:** Any Silken Windhound ASFA Field Champion of record. **VETERAN STAKE:** Any eligible Silken Windhound that has met the certification requirements and whose age is at least six years. Points go toward V-FCh or V-LCM titles.

**SINGLES STAKE:** Any eligible Silken Windhound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPX titles from the Singles stake. Provisional breeds are not eligible for these titles.

### HOW TO ENTER

**Scanned/E-mailed entries are acceptable. However, payment MUST be made at the time of sending entries using the payment option on the Michigan Gazehound Association website. The email payment confirmation you receive from PayPal can be forwarded to the FTS as proof of payment.**

**MAILED entries may be paid by either a check in US Funds or by using the payment button at the Michigan Gazehound Association Website.**

**Online entries are also accepted via the AKC entry forms for sighthounds at the Michigan Gazehound Association website. Payment can be made after submitting your online entries.**

### NO EXCEPTIONS.

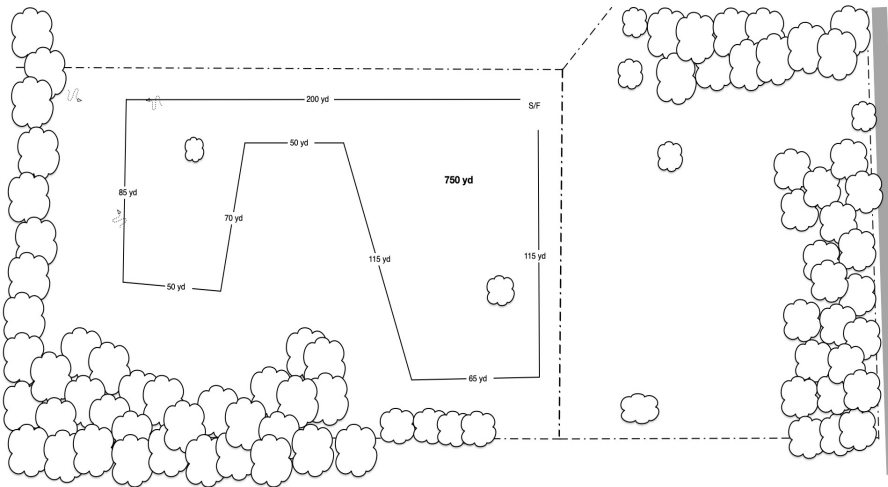
**If you have NOT provided payment by roll call on the day of trial, your entry will be considered conditional and not accepted.**

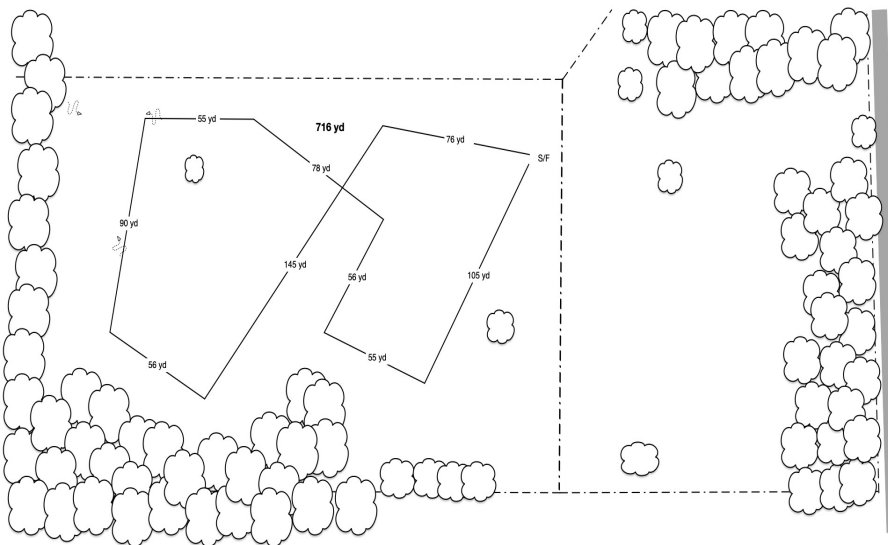

- Gas-powered continuous loop lure machines will be used, with backup equipment on site
- The lure will consist of highly visible white or black plastic strips and/or fur strips
- Course may be altered as required by weather or field conditions
- Course will be reversed for finals
- A \$5.00 fine will be collected from the handler of any non-competing hound running loose on the field during the course in progress, and from any person not cleaning up after his/her hound.
- A pool with water will be on-site for cooling off dogs

- There is a small downhill walk to get from parking to the running field. Accommodations can be made to get you to the field as necessary.
- Field is completely fenced.
- Please do not go around the roped off areas.
